SUBJECT: Approval of a Resolution Ratifying a Raffle License for Colton Mittman Fundraiser; drawing held on September 12, 2015, and waiving all fees.

SUMMARY AND BACKGROUND OF SUBJECT MATTER:

On July 13, 2015 the attached application was submitted to request a raffle license pursuant to Village Code 4-10-2, for the Colton Mittman Fundraiser. Colton Mittman was diagnosed with Cerebral Palsy at the age of 2, and has been fighting ever since. His family has found a possible treatment, and are hosting a fundraiser to help fund his treatment. Village Code Section 4-10-2(B) states that "*Licenses may be issued only to ... a nonprofit fundraising organization that the village determines is organized for the sole purpose of providing financial assistance to an identified individual or group of individuals suffering extreme financial hardship as the result of an illness, disability, accident or disaster.*" The raffle tickets were scheduled to be sold at the Antioch VFW on Sunday, July 19, 2015, with the drawing to be held on September 12, 2015. The applicant requested that the fees be waived for this raffle.
