SUBJECT: Consideration of a Resolution Authorizing the Village Board to accept from the Greater Round Lake Fire Protection District a 2003 Ford E350 Ambulance to be used by the Antioch Fire Department for EMS service to the community.

SUMMARY AND BACKGROUND OF SUBJECT MATTER:

For the past three years the Greater Round Lake Fire Protection District has been able to help provide the Antioch Fire Department with a backup ambulance for situations when one of our primary ambulances was out of service. Recently, the Board of Trustees for the Greater Round Lake FPD declared their 2003 Ford E350 Ambulance as surplus. Further, as surplus equipment, their board resolved to donate this ambulance to the Antioch Fire Department to function as a reserve unit in times of need.

WHEREAS, the mission of the Antioch Fire Department is to provide fire and life safety services to the community, and

WHEREAS, the Antioch Fire Department currently provides emergency medical services for the Village of Antioch and the unincorporated areas served by the First Fire Protection District as a principal part of their mission, and

WHEREAS, the Antioch Fire Department has determined that it would be an efficient cost effective solution to add an additional reserve ambulance to supplement its immediate fleet needs, and

WHEREAS, the Antioch Fire Department often finds the need to have two reserve ambulances to ensure proper coverage, and

WHEREAS, the Greater Round Lake Fire Protection District has offered to donate their 2003 Ford E350 Ambulance to the Antioch Fire Department as a reserve response vehicle, and

NOW, THEREFORE, BE IT HEREBY RESOLVED BY THE MAYOR AND VILLAGE BOARD OF TRUSTEES OF THE VILLAGE OF ANTIOCH, LAKE COUNTY, ILLINOIS, to authorize the Village Administrator to accept this ambulance to be used for EMS service to the Village of Antioch by the Antioch Fire Department.
