## **RESOLUTION NO. 16-83**

## RESOLUTION AUTHORIZING THE VILLAGE ADMINISTRATOR TO ENTER INTO A CONTRACT WITH MOTOROLA SOLUTIONS FOR STARCOM21

WHEREAS, the Village of Antioch, Lake County, Illinois (the "Village") is a duly organized and existing municipality created under the provisions of the laws of the State of Illinois; and

**WHEREAS**, The Village of Antioch Police Department is currently a member of the Northwest Radio Network, a public safety communications consortium.

**WHEREAS**, The Northwest Radio Network is an aging system with limited radio signal coverage, no interoperability with other public safety entities outside of the Network, and lacks the capacity for multi-frequency utilization during critical incidents, thus compromising safety and operations;

**WHEREAS**, Starcom21 is the official, statewide public safety radio network of Illinois, and is a 700/800 Mhz public safety communications system with an existing network of over 270 radio tower sites, including sites in Antioch.

WHEREAS, Starcom21 allows for interoperability with other public safety agencies across the State of Illinois; provides exemplary radio coverage throughout the Village; allows for multiple channels and talk groups for critical incident operations; provides for high level communication operations at all levels and Departments throughout the Village;

WHEREAS, Motorola Solutions, Inc. of Schaumburg, Illinois has built and maintains the Starcom21 infrastructure, and has been awarded contract #CMS3618850 through the State of Illinois to provide StarCom21 products and services.

**WHEREAS**, The Northwest Radio Network consortium has elected to migrate to StarCom21, rather than continue to maintain an aging network that does not meet the needs of the public safety entities.

WHEREAS, The Village of Antioch Police Department staff has recommended purchasing portable radios and dispatch consoles that are compatible with the StarCom21 system for the purpose of integrating the Village's public safety radio communications onto the StarCom 21 network, pursuant to certain Communications System Agreements, Equipment Lease-Purchase Agreement, Software User Agreement and Starcom21 User Agreement provided by Motorola Solutions, Inc. The agreements allow the Village to pay for this equipment over a five year period with zero interest, resulting in an expenditure not to exceed \$220,000.

**NOW, THEREFORE, BE IT HEREBY RESOLVED BY THE MAYOR AND VILLAGE BOARD** do hereby authorize the Village Administrator to execute any and all agreements with Motorola Solutions, Inc. for the lease-purchase of equipment for the implementation of Starcom21, not to exceed \$220,000.
