WHEREAS, these services Synagro LLC provides are the removal of the bio-solids from the Treatment Facility bio-solids storage area to a farm field where the solids are incorporated into the soil, and

WHEREAS, in 2017 these services were put out to bid, and

WHEREAS, Synagro was the lowest bidder at \$21.99 per cubic yard, and

WHEREAS, Synagro new price for 2018 is \$22.36, less than a 2 % increase, and

WHEREAS, this amendment will commence on March 7, 2018 and continued through March 6th, 2019

NOW, THEREFORE, BE IT HEREBY RESOLVED BY THE MAYOR AND VILLAGE BOARD OF TRUSTEES OF THE VILLAGE OF ANTIOCH, LAKE COUNTY, ILLINOIS, to authorize the Village Administrator to execute an amendment to the existing contract with SYNAGRO for the Transportation and Land Application of Bio-Solids.

NOW, THEREFORE, in consideration of the mutual covenants contained herein the parties hereto intending to be legally bound hereby agree as follows:

- 1. The term of the contract shall be extended for a period of one (1) year commencing on March 7, 2018 and continuing through March 6, 2019. Customer and Service Provider further agree that at the end of this term, this Contract may be extended for additional periods as mutually agreed in writing by both parties.
- 2. The pricing set forth in this amendment reflects an increase by the adjustment in the Consumer Price Index (CPI) for the Chicago- Gary- Kenosha, IL- IN- WI index; All items; Not Seasonally Adjusted;

The adjusted price effective March 17, 2018 shall be:
