



A resolution providing for the retirement of certain municipal indebtedness by the use of motor fuel tax funds

WHEREAS, the MUNICIPALITY of ANTIOCH has outstanding indebtedness described as follows:

GENERAL OBLIGATION REFUNDING BONDS, SERIES 2013 MFT Section Number: 13-00046-00-GB (Title of bond issue or paving district and municipal motor fuel tax section number)

WHEREAS, in the opinion of this body, the indebtedness described in the preceding paragraph may be retired with funds allotted to the municipality under the Motor Fuel Tax Law, and

WHEREAS, it appears that sufficient motor fuel tax funds are or will be available when the above indebtedness is due, and

WHEREAS, the MAYOR AND BOARD OF TRUSTEES has, by resolution adopted Res. #18-86, directed the Clerk of LAKE County to cancel the 2018 tax levy (for taxes collectable in 2019) which would have produced funds to pay this indebtedness. (Not applicable to special assessment projects.)

NOW, THEREFORE, BE IT RESOLVED, that there is hereby appropriated the sum of One hundred and sixty-nine thousand, nine hundred and fifty dollars (\$ and zero cents) from funds allotted to the county or municipality under the Motor Fuel Tax Law for the payment of the above-described indebtedness, and

BE IT FURTHER RESOLVED, that the Clerk shall immediately transmit three (3) certified copies of this resolution to the Regional Engineer, Department of Transportation, Schaumburg, Illinois.
