A RESOLUTION AUTHORIZING THE VILLAGE ADMINISTRATOR TO EXECUTE AN AGREEMENT WITH JACOBSEN EXCAVATING INC. TO DEMO THE FIVE (5) STRUCTURES ON THE PROPERTY LOCATED AT 22821 W. NORTH AVENUE

WHEREAS, the Village of Antioch, Lake County, Illinois (the "Village") is a duly organized and existing municipality created under the provisions of the laws of the State of Illinois; and

WHEREAS, the Village staff has received proposals based on professional contractors' observations of the Village buildings located at 22821 W North Avenue, which are included in the bid tab sheet attached as Exhibit "A"; and

WHEREAS, Jacobsen Excavating Inc. submitted the lowest quote in the amount of \$47,390.00; and

WHEREAS, the Village Board finds that demolition of the buildings located on the property is in the best interest of the Village and its residents,

NOW, THEREFORE, BE IT HEREBY RESOLVED BY THE MAYOR AND VILLAGE BOARD OF TRUSTEES OF THE VILLAGE OF ANTIOCH, LAKE COUNTY, ILLINOIS, to authorize the Village Administrator to execute an agreement with Jacobsen Excavating Inc to demo 5 structures on the property located at 22821 W North Avenue.


