## A RESOLUTION APPROVING THE VILLAGE BOARD OF TRUSTEES 2021 AMENDED MEETING SCHEDULE

WHEREAS, the Regular Meetings are now scheduled for the second and fourth Wednesday of every month at 7:00 p.m. (the "Amended Regular Meetings"); and

WHEREAS, the schedule of Amended COW Meetings and Amended Regular Meetings (the "Amended Schedule") will be published in accordance with the Illinois Open Meetings Act (5 ILCS 120, et seq.) in the same or substantially similar notice attached hereto as Exhibit A; and

WHEREAS, all other board and commission meetings will remain on their regularly scheduled meeting dates as set forth in Resolution No. 20-49;

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Board of Trustees of the Village of Antioch, Lake County, Illinois, as follows:

Section 1. The Amended Schedule is hereby approved by the Corporate Authorities.

<u>Section 2</u>. Any resolution or portion of any resolution in conflict with any provisions of this Resolution is hereby repealed solely to the extent of such conflict.

Section 3. This Resolution shall be in full force and effect after passage as provided by law.
