MINUTES of a regular public meeting of the President and Board of Trustees of the Village of Antioch, Lake County, Illinois, held at the Antioch Municipal Building, 874 Main Street, Antioch, Illinois 60002 in said Village at 6:30 o'clock p.m. on the 28th day of July, 2021.

The meeting was called to order by the Village President, Scott Gartner, and upon the roll being called by the Village Clerk, the following Trustees answered present: Macek, Pedersen, Bluthardt, Burman and Dominiak.

The following attended the meeting by video or audio conference: Pierce.

The following were absent: None.

The Village Clerk announced that the Bond Issue Notification Act of the State of Illinois required a declaration of the intention of the Village to issue non-referendum general obligation alternate bonds of the Village in an amount not to exceed \$9,000,000 to provide additional funds to refund the Village's outstanding Waterworks and Sewerage Revenue Bond, Junior Lien (IEPA), Series 2008, dated April 25, 2008 and an outstanding loan agreement with the Illinois Environmental Protection Agency, being the L17-0356 Loan payable of 2007, and that the President and Board of Trustees was required to hold a public hearing prior to the adoption of an ordinance providing for the sale of said bonds and the levy of a direct annual tax to pay the principal and interest thereon.

Whereupon the Village Attorney presented and read in full a resolution as follows:

RESOLUTION NO: 21-53

RESOLUTION concerning a hearing required to be held pursuant to the Bond Issue Notification Act of the State of Illinois prior to the sale of General Obligation Bonds (Alternate Revenue Source), Series 2021 of the Village of Antioch, Lake County, Illinois.

WHEREAS, pursuant to the provisions of The Municipal Code of the State of Illinois, and all laws amendatory thereof and supplementary thereto (the "Municipal Code"), the Village of Antioch, Lake County, Illinois (the "Village"), is authorized to issue non-referendum general obligation alternate bonds for various purposes of the Village; and

WHEREAS, before the Village may adopt an ordinance selling non-referendum general obligation alternate bonds, the President and Board of Trustees of the Village (the "Board") proposing to sell the bonds shall hold at least one public hearing concerning the Village's intent to sell the bonds pursuant to the Bond Issue Notification Act of the State of Illinois (the "Act"); and

WHEREAS, pursuant to the Act, the Village Clerk of the Village shall publish notice of the hearing at least once in a newspaper of general circulation in the Village not less than seven (7) nor more than thirty (30) days before the date of the hearing; and

WHEREAS, on the 14th day of July, 2021, notice of the hearing was published once in *Lake County News-Sun*, the same being a newspaper of general circulation in the Village, and an affidavit evidencing the publication of such notice, together with a newspaper clipping of such notice as published attached thereto, having heretofore been presented to the Board, and made a part of the permanent records of the Board; and

WHEREAS, notice of the hearing was given by posting at least forty-eight (48) hours before the hearing a copy of the notice at the principal office of the Board; and

WHEREAS, at the hearing, the Board shall explain the reasons for the proposed bond issue and permit persons desiring to be heard an opportunity to present written or oral testimony within reasonable time limits:

NOW, THEREFORE, Be It and It Is Hereby Resolved by the President and Board of Trustees of the Village of Antioch, Lake County, Illinois, as follows:

Section 1. Incorporation of Preambles. The Board hereby finds that all of the recitals contained in the preambles to this resolution are full, true and correct and does incorporate them into this resolution by this reference.

Section 2. Hearing. The persons desiring to be heard presenting written or oral testimony on this date were as follows:

See Schedule 1 attached hereto and made a part hereof.

The hearing was finally adjourned at 6:36 p.m. on the 28th day of July, 2021.

Section 3. Decision to Proceed. Upon review of the written and oral testimony, the Board deems it advisable, necessary and for the best interests of the Village that the non-referendum general obligation alternate bonds be sold and that the ordinance selling said bonds be adopted after a period of at least seven (7) days after the date hereof.

Section 4. Severability. If any section, paragraph or provision of this resolution shall be held to be invalid or unenforceable for any reason, the invalidity or unenforceability of such section, paragraph or provision shall not affect any of the remaining provisions of this resolution.

Section 5. Repeal. All resolutions or parts thereof in conflict herewith be and the same are hereby repealed and this resolution shall be in full force and effect forthwith upon its adoption.
