**Special Events Report**

Winter Wine Walk update- This event sold out with an additional 80 people on a waiting list for tickets. The event was held from 2-5 p.m. and consisted of 8 businesses with a total of 41 wines. Due to popularity Shawn is planning another wine walk in the summer (June) and fall (September).

4<sup>th</sup> of July discussion- The parade route needs to be changed due to road construction. We are going out for bid this year for fireworks. We are looking to make this a more theme oriented parade with floats and decorations being a requirement. This will cut down on cars participating for advertisement only. Some fundraising will likely be done to offset the price of the fireworks and events.
