I. **Call to order**

A meeting of the Police and Fire Commission was called to order at State Bank of The Lakes, 440 Lake St. Antioch, IL 60002 at 4:08 PM on Wednesday July 29, 2021.

II. **Roll Call**

a. **Sergeant Promotion List**

1. Consideration for the recommended promotion of Audra Bonaroti to Sergeant

Based on staffing movement a vacant position was created for a sergeant. Chief Guttschow requested the promotion of Audra Bonaroti, who is currently in the first spot on the Sergeant's Promotion List. A motion was made by

Commissioner Zeason and seconded by Commissioner Volling to approve the promotion request. The motion passed unanimously.
