FIRST AMENDMENT

to

PERSONNEL SERVICES AND AMBULANCE BILLING CONTRACT

This First Amendment to Personnel Services and Ambulance Billing Services Contract is entered into effective November 7, 2016 by and between METRO PARAMEDIC SERVICES, INC., an Illinois Corporation (hereinafter referred to as "Contractor") and the VILLAGE OF ANTIOCH, (hereinafter referred to as ("VILLAGE"):

WITNESSETH:

WHEREAS, METRO and VILLAGE are parties to a certain Personnel Services and Ambulance Billing Services Contract dated August 14, 2015 ("Contract") whereby METRO contracted to supply Personnel Services and Ambulance Billing Services to the VILLAGE in accordance with the terms of the Contract and for three years, beginning September1, 2015 and ending August 31, 2018;

WHEREAS, the parties have agreed to make certain changes to the terms of the Agreement regarding the number of personnel provided by METRO;

NOW, THEREFORE, in accordance with Article 19 of the Contract and in consideration of the mutual covenants herein contained, the parties hereby amend the Contract as follows:

ARTICLE 4:

Article 4 is hereby amended by adding the following provisions:

Beginning November 21, 2016, METRO shall provide an additional three (3) full-time EMT Paramedic Firefighter(s) to serve as Shift Commanders to the VILLAGE, each of whom shall be assigned to work a rotating schedule of 24 hours on duty to be followed by 48 hours off duty.

ARTICLE 6:

Article 6 is hereby amended by adding the following provisions:

In consideration for the additional services to be provided by Contractor to Village pursuant to the provisions of this Agreement including but not limited to the duties to be performed by Contractor's personnel, Village will pay Contractor for EMT Paramedic Firefighter Shift Commander Services as follows:

During Years Two (2) and Three (3) of the Contract, the District will compensate METRO:

- a. Commencing November 21, 2016 for a period of 12 months, a monthly installment of \$22,180.92 totaling \$266,171.00.
- b. Commencing November 21, 2017 for a period of 12 months, a monthly installment of \$22,846.33 totaling \$274,156.00

Unless specifically changed in this First Amendment, the provisions of the Contract remain in effect. If any provision of this First Amendment conflicts with the Contract, this First Amendment shall control.
