## **FEES**

All fees along with required escrow shall be paid at the time of submittal of the application. (checks made payable to the Village of Antioch)

- -30 copies of the Preliminary Plan, Landscape Plan, Elevations, Photometric Plan, Design Guidelines, of subject property along with three (3) copies of a survey signed by an Illinois licensed surveyor with dimensions accurately portraying the proposed request. Folded and legible  $8\,1/2\,x\,11$  copy.
- -30 copies of Patten Book (Single Family Design Guidelines)- if applicable
- -Typed and Digital Copy of Legal Description
- -A written letter stating the nature of the proposed Preliminary Plan including the proposed reasons.
