VILLAGE OF ANTIOCH BOARD OF TRUSTEES; REGULAR MEETING Municipal Building: 874 Main Street, Antioch, IL September 6, 2011

I. CALL TO ORDER

Mayor Hanson called the September 6, 2011 regular meeting before the Board of Trustees to order at 7:30 p.m. in the Antioch Municipal Building: 874 Main Street, Antioch, Illinois.

II. PLEDGE OF ALLEGIANCE

Members of Boy Scout Troop #92 who were present in the audience led in the Pledge of Allegiance.

III. ROLL CALL

Following the Pledge of Allegiance, roll call indicated the following Trustees were present: Pierce, Sakas, Poulos, Crosby, Dominiak and Jozwiak. Also present were Mayor Hanson, Administrator Keim, Attorney Long and Clerk Rowe.

IV. MAYORAL REPORT

Mayor Hanson said this is a very important week in history and he discussed the 10 year anniversary of the 911 tragedy that took place in 2001. He said the Village of Antioch will be holding a 9/11 tribute at the William E. Brook Memorial Bandshell located at 902 Skidmore Drive at 7:30 p.m. on Sunday, September 11, 2011. He said this would be a candlelight ceremony and all citizens of Antioch and of the surrounding communities are invited to join Antioch's elected officials, administration and staff for this ceremony.

There were no citizens present in the audience who wished to address the Board.

6. Approval of an Ordinance amendment to Section 10-6A-a, 10-6B2 and 10-15-5 of the Municipal Code of Antioch regulations to Pawn Shops, Places of Assembly, Taverns and Liquor Licenses and Special Use approvals. Ordinance was first read on August 15, 2011; Ordinance No. 11-09-14 – Attorney Long gave a brief summary of the amendments to the code and stated there were no changes to the ordinance since it was reviewed at the August 15, meeting.

Trustee Pierce moved, seconded by Trustee Dominiak to approve as presented and publish in pamphlet form **Ordinance No. 11-09-14** regarding amendments to Section 10-6A-a, 10-6B-2 and 10-15-5 of the Antioch Municipal Code. Upon roll call, the vote was:

8. Consideration of Resolution accepting the Police and Fire Commissioners Annual Report and Adopting the 2011 Rules & Regulations; *Resolution No. 11-82* – Police and Fire Commission Chairman Ed Macek reviewed his memorandum and briefly discussed the amendments to Rules and Regulations as approved by the Police and Fire Commission on August 3, 2011.

Trustee Pierce moved, seconded by Trustee Crosby to approve **Resolution No. 11-82** accepting the Police and Fire Commission's Annual Report and adopt the Police Commission Rules and Regulations as amended August 3, 2011. Upon roll call, the vote was:

YES: 6: Pierce, Sakas, Poulos, Crosby, Dominiak and Jozwiak.

NO: 0.

THE MOTION CARRIED.

9. Consideration of a Resolution for a Special Event Liquor License for the Limerick Lounge; Resolution No. 11-83 – Al Anderson, owner of the Limerick Lounge said they were approached by the Chamber regarding the upcoming craft fair. He said they would like to permission to sell alcohol to people attending the fair and would like them to be able to walk around the event with their drinks. Attorney Long explained the provision in the Village code that states alcohol must be consumed within the property area unless licensed to do otherwise. Chief Somerville said the request was discussed with staff and suggested that participants wear wrist bands and that proper signage be posted. Trustee Dominiak said that she is struggling with the request because of the code and she expressed concerns regarding setting precedence and littering. She said that she doesn't see what the benefit is to have alcohol at the Arts and Craft fair. Board members discussed other events such as the Wine Walks, Thursday concert series and the Taste of Antioch. Following further discussion, Mr. Anderson agreed to work with the Chamber to have wrist bands and to post proper signs instructing those participating that drinks must stay within a certain area.

Trustee Pierce moved, seconded by Trustee Sakas to approve **Resolution No. 11-83** for a Special Event Liquor License request from the Limerick Lounge for the Arts & Crafts Fair to be held on September 10 & 11, 2011, waiving all fees. Upon roll call, the vote was:

YES: 5: Pierce, Sakas, Poulos, Crosby, and Jozwiak.

NO: 1: Dominiak.

10. Consideration of a Resolution authorizing the Village Administrator to purchase four camera systems from Mobile-Vision Inc. in the amount of \$19,592.60; Resolution No. 11-84 – Police Chief Somerville explained the camera system will be purchased with DUI funds and not taxpayer dollars. Trustee Crosby moved, seconded by Trustee Dominiak to approve Resolution No. 11-84 authorizing the Village Administrator to purchase four camera systems from Mobile-Vision Inc. in the amount of \$19,592.60. Upon roll call, the vote was:

YES: 6: Pierce, Sakas, Poulos, Crosby, Dominiak and Jozwiak.

IX. ADMINISTRATOR'S REPORT

Administrator Keim updated the Board regarding the Lake Michigan water study. He said that including Lake County, there are now 7 members involved in the group. He said that he attends technical group monthly meetings and Trustee Jozwiak attends monthly policy group meetings. He briefly discussed recent reports and said the groups are analyzing the information and possible alternate options with other communities. Administrator Keim said the cost estimates have been updated to be about \$270 million dollars. Administrator Keim suggested that we look at all of options and to possibly commission our own studies. He expects to have some final reports from the group next month. Board members discussed their concerns and stated that before moving forward with the Lake Michigan water project, there would need to be public education sessions and have the referendum question be on a future ballot. Administrator Keim explained that we should have ground water reports next month and that our next step should be reviewing these reports. Trustee Jozwiak explained that we have to be careful and review all the information before making any decisions, because once we drop out, we cannot get back into the group. Mayor Hanson said that we may have to make tough decisions for the future. He said the Board must be responsible, smart and take steps to the secure our future. He thanked Administrator Keim and Trustee Jozwiak for making our voices be heard at these meetings.

X. VILLAGE CLERK'S REPORT

No report.

XI. TRUSTEE REPORTS

Trustee Jozwiak reported that the repairs to Well 9 are coming along. He said the road program in the Woods of Antioch subdivision is going well and he expects Depot Street and Sprenger Park projects to begin this week.

DRAFT MINUTES

Trustee Dominiak said that she has heard positive feedback regarding the post card that was mailed notifying residents of the water and sewer rate change. She also said that a meeting has been scheduled at 7:30 p.m. on September 29th with representatives from the Healthcare Foundation of Northern Lake County to discuss the health care needs and access opportunities in the community.

Trustee Crosby discussed Chief Somerville's suggestion regarding the Board room. A team of volunteer employees will work on painting and redecorating the meeting room.

Trustee Poulos asked if the cell phone ordinance signs were installed. Administrator Keim said the signs have come in, but he didn't believe they were installed. He will follow up with Public Works Director Heimbrodt.

Trustee Sakas asked if the cement work was done in the Woods of Antioch subdivision. Administrator Keim said the project was about fifty percent completed last week Friday.

Trustee Pierce asked Administrator Keim if he had an opportunity to look into the electric co-op programs similar to what is in place in Grayslake. Administrator Keim said it looks like Grayslake is going to referendum regarding that matter. Trustee Pierce asked about the curfew ordinance. Administrator Keim will provide Board members with a copy of the ordinance and will place this item on the next committee of the whole meeting.

XII. EXECUTIVE SESSION; Pending Litigation and Lease of Property

Trustee Crosby moved, seconded by Trustee Jozwiak for the Mayor and Board of Trustees to go into executive session at 8:38 p.m. to discuss pending litigation and lease of property. Upon roll call, the vote was:

<u>SUBJECT</u>: Authorization to the Village Administrator to draft and execute a letter of Engagement with Hinshaw and Culbertson; initiating the application process to amend the Village's Facility Planning Area Boundary.

SUMMARY AND BACKGROUND OF SUBJECT MATTER:

The Village is allowed to service only those properties with sewer services that are located within its Facilities Planning Area (or FPA). This geographic area is established by the EPA and contains properties incorporated and outside the Village limits. The proposed amendment to this boundary would add additional lands that could be served by the Village's waste water reclamation facility. With the added capacity to the waste water collection system, the Village has the ability to add users and expand the areas that it may now serve.

This process for expanding the service area includes applications and hearings to the Chicago Metro Agency for Planning and demands specialized legal and engineering representation. By law, the Village, not private property holders can apply to amend the boundary.

The Village has identified three particular properties that would benefit from the extension of the sewer service by expanding the opportunity for new development, redevelopment, and private investment. These sites have been identified for the boundary amendment and are included in the attached map. They include, Emmons School, which is outside the corporate limits of the Village and currently is serviced by a private sewer system, Sequoit Harbor, which is within the Village Corporate limits, and is currently served by a private sewer system, and 16 acres owned by Spiro Hortis, which is located within the Village limits, and is currently vacant with no services. Staff has discussed this opportunity with each owner and based upon their interest to proceed and fund the amendment process, solicited proposals for specialty legal counsel, to manage the FPA application and amendment process.

If the Board agrees in principal to the idea of expanding the service area, staff and legal counsel will draft a letter of Engagement for proposed scope of services. The amendment, if approved, does not obligate the Village to extend sewer service to the properties, but is essential if the Village or private property seeks to extend and connect to our utilities.



Dear Mr. Nilsen:

Thank you for providing the verbal explanation and supporting map of the existing FPA and the three affected properties. As you know, I previously represented the Village in connection with an FPA boundary change proposal which related to the Beelow parcel and a proposed annexation of a parcel owned by Diamond Development, LLLC. As well, about two years ago, I worked briefly with Emmons School to review the record of proceedings before the IEPA hearing officer to determine if there was a basis for determining that the school was included in the Antioch FPA by reason of the prior application. As you may know, we worked on an Intergovernmental Agreement with the Village of Fox Lake, who at that point was the designated management agency for the Northwest Lake Facility Planning Area, within which the Emmons School property was located. Much of this background seems to be pertinent to the current proposal and our familiarity and history with this matter should improve our efficiency.

Based upon our discussion and my brief review, it appears that there are sound reasons for including each of the three parcels. Given that treatment plant PE capacity is not a problem, I do not see any basis for a compelling engineering objection against the proposed action. Certainly, there is always the possibility of community and environmental objections based on particular proposed uses.

As you likely know, the Chicago Area Agency for Planning is the successor to NIPC responsible for reviewing the Applications for FPA alterations. CMAP undertakes its review from a perspective of long term planning and the interrelatedness of water use and water quality issues. CMAP must make a recommendation to the Illinois EPA on whether to approve an application. This means that requests for supplemental effort are sometimes forthcoming from CMAP staff when Applications are submitted. We would expect to attend a pre-application meeting with CMAP staff, along with the Village Engineer. Until CMAP has commented on the Antioch FPA expansion the timeframe and cost of the process arte a bit conjectural. The CMAP "checklist" for Applications is fairly detailed. We attach a copy for reference.

As I understand your legal services request, the Village seeks to retain special counsel for at least the following purposes:

- <u>Application Submission</u> Work with Village staff, including the Village Engineer, and other interested property owners and their counsel, attend necessary meetings and conferences, provide legal support, assistance and legal interpretations concerning the preparation and submission of a FPA boundary change application and related supporting information to appropriate authorities to incorporate the three new parcels identified on the drawing you provided in order to gain appropriate legal authority to service the three parcels;
- <u>Application Processing</u> Assist staff and interested parties as required during the administrative and legal review of the FPA boundary change application; and
- Administrative Hearing and Related Legal Proceedings Provide legal representation to the Village in connection with any public meetings or CMAP administrative processing (including pre-Board review conferences), and discussions with Illinois EPA which are required to secure necessary approvals. Beyond the routine hearings and meetings, and because there is some disagreement within Illinois about how the FPA process should work, there is always a prospect of some person or group deciding that a given FPA expansion is a bad idea. The likelihood of a contested hearing or court challenge and the probable length of such are not susceptible to estimate at the outset, and a supplemental budget would be required in the event such services will be needed.

As you probably realize, I may be assisted from time to time by other attorneys at Hinshaw & Culbertson LLP, who practice chiefly in the Environmental Law area. It is likely that Mr. Harvey Sheldon will assist me should we be retained by the Village. Copies of our firm resumes are attached. Because I live in Grayslake and because we have an office located in Lake Bluff, I do not anticipate that significant travel expenses or travel time will be required for meetings and conferences. As well, in light of my familiarity with your community and my past representation of the Village's interests on issues including your FPA, I anticipate that I can quickly and efficiently undertake and execute this engagement. I am not aware of any conflicts. As you know, our firm has worked with the Village on several occasions. Harvey Sheldon is well versed in the requirements of the Clean Water Act that impact the FPA approval process, and has experience with wastewater treatment plant and wetlands issues in Lake County and elsewhere. Harvey is also acquainted with Frank Beal, one of the CMAP board members on the Committee that recommends whether Applications be approved.

Should you elect to retain my services, an engagement letter confirming the Village's understanding of the law firm's undertakings and requirements, will be required. When that is concluded, our work may begin.

As we discussed, the cost of legal matters of this type is difficult to estimate. While some aspects are routine, the level of community resistence is often difficult to predict and that contingency greatly influences the extent and expense of legal services and additional consultants. In addition, the position of Lake County on the Hortis parcel is unknown, and the position they take may have a material effect on the legal effort required.

For environmental legal matters, my usual rate is \$350/hour. For the initial tasks of assisting with the application preparation, including initial discussions with Village staff and interested parties, and CMAP staff preapplication meetings and discussions, I roughly estimate that fees would be in the range of \$7,000 - 10,000. Application processing should be less, in the range of 4500 - 8,000. Harvey's environmental rates are substantially higher, but he will serve Antioch at a substantial discount for the same 350 rate.

Anticipating issues of fair cost sharing, I suggest that the Village require that the three affected property owners be requested to post a deposit or retainer with the Village against its likely legal expenses with the understanding that the initial allocation of approximately \$6000 each may have to be adjusted if issues unique to a particular parcel cause a material shift or inequality in the level of legal services required, e.g., to address a site specific issue such as SSA impacts or particular political issues. If CMAP staff seeks some sort of additional or supplemental project that is properly assessable to the Village at large, the Village should be prepared for the prospect of assessing itself some share of the cost of evaluation. Our work would be undertaken on behalf of the Village, but we would endeavor to track activity unique to a specific property so there would be a basis should a retainer adjustment be necessary.

Please contact me if you have questions or if I have failed to respond to your request in any way. I certainly hope that I will have the opportunity to work with you again.

CMAP is the designated area-wide water quality planning agency for Northeastern Illinois and the advisory comprehensive regional planning agency for northeastern Illinois. Therefore, CMAP needs to act as a consensus builder by promoting good planning. Though not specifically required by the Illinois Environmental Protection Agency (IEPA), non-italicized items on the checklist outline the items needed to specifically address CMAP's regional role and to promote good planning. Italicized items are needed to fulfill the requirements of the IEPA and CMAP.

<u>Checklist A</u> is a list of basic submittals that applicants should include for **both Facility** Planning Area amendments and Waste Water Treatment Plant Applications. <u>Checklist B</u> is a list of submittals for an application for Boundary Modifications only. <u>Checklist C</u> is a list of submittals for an application for Facility Construction or Expansion Application Only.



Professional Background

Mr. Sheldon was the Chief of the Illinois Attorney General's Environmental Enforcement Division in the early 1970s, supervising 20 lawyers and a staff of investigators in the representation of the State and the Illinois EPA. His work in environmental enforcement began in January 1972, before several of the major federal laws governing the subject were even enacted. He supervised a docket of hundreds of proceedings that involved air, water, and land pollution cases.

His Division was responsible for the establishment of precedent on the federal common law of water pollution in interstate waters, in cases such as *Illinois v. Milwaukee*. Mr. Sheldon filed the State's *amicus curiae* brief that urged the Supreme Court to require rules on prevention of significant deterioration as part of the Clean Air Act regulatory scheme (*Sierra Club et al v. Ruckelshaus*). In addition to supervising and directing the attorneys of the Division, he tried environmental enforcement matters in court and in administrative proceedings; he also argued a number of cases on appeal in both State and Federal court.

In the mid-1970s, Mr. Sheldon was named the Regional Counsel of the United States Environmental Protection Agency Region 5 (Midwest Region) office in Chicago. He was the principal EPA attorney for six Midwestern states: Illinois, Indiana, Michigan, Minnesota, Ohio and Wisconsin. Mr. Sheldon worked with state legislatures on the adoption of state water laws and helped the EPA establish state programs under the Clean Water Act. He assisted enforcement attorneys and United States' attorneys in important enforcement actions. He also recommended improvements in the legislative criteria for federal grants to upgrade public water treatment plants, and otherwise advised the Regional Administrator on numerous issues.
