

**OFFICIAL NOTICE TO BIDDERS**

**Lake Street Lift Station Improvements**

**OWNER AND WORK:** The Village of Antioch, Illinois, hereby gives notice that sealed Bids will be received for the construction of the Lake Street Lift Station Improvements. The Work of the Contract is generally described as follows:

The Project includes furnishing all labor, materials, and equipment and performing all work generally described as follows:

- Constructing a replacement lift station and appurtenances, located adjacent Lake Street, east of Tiffany Road, for the Village of Antioch herein after called OWNER.
- Sanitary service shall not be interrupted to the Village system user. The Work will include but is not limited to the following activities:
  - Construction of a 750 gpm submersible pump duplex lift station with wet well and valve vault, with emergency backup generator.
  - Conversion of the existing wet well to a manhole.
  - Abandonment in place of the existing valve vault.
  - Coordination with Automation contractor and installation of necessary SCADA equipment.
  - Additional work will include site clearing, grading and landscape, and connections to existing gravity and pressure sewers.

**TIME AND PLACE OF BID OPENING:** Sealed bids will be received until **11:00 a.m.**, local time, on **May 5, 2011** at the Village of Antioch Village Hall, 874 Main Street, Antioch, Illinois. All bids must be submitted in sealed envelopes upon the blank form included in the Bid Package. *(Do not remove form from Bid Package)* Sealed envelopes shall be marked in the upper left hand corner as follows:

After the official bids closing time, the bids will be publicly opened and read aloud.

**BIDDING DOCUMENTS:** The Bidding Documents and the Contract may be examined at the offices of the Owner, 874 Main Street, Antioch, Illinois, and Engineer as listed below. The Bidding Documents will be available for purchase or review on **April 12, 2011**. Include company name, street address, name of contact person, telephone number, and fax number with application. A **\$100.00** nonrefundable payment for each set of Bidding Documents is required. The drawings included in the Bidding Documents are full-scale. Persons requesting documents to be sent by mail shall include an additional **\$20.00** per set to cover postage and handling. Make Check or money order payable to SEC GROUP, INC.

**SUBSURFACE CONDITION REPORTS:** Reports of explorations and tests of subsurface conditions used in preparing the Bidding Documents are included in the Appendix.

**WAGE RATES:** The CONTRACTOR'S shall be required to comply with the most recently publicized "Lake County Development Block Grant, Contract Compliance Package." A copy of this package is incorporated in the Contract Documents and Federal Wage Rates by state and county are available at the following site:

The rates of pay are the minimums to be paid during the life of the contract. It is therefore the responsibility of Bidders to inform themselves as to local and federal labor conditions, such as length of work day and work week, overtime compensation, health and welfare contributions, labor supply and prospective changes or adjustments of rates.

**PRE-BID CONFERENCE:** A **mandatory** pre-Bid conference is scheduled for **11:00 a.m., April 20, 2011**, at the Village of Antioch Village Hall, 874 Main Street, Antioch, Illinois.

**BID SECURITY:** Bid Security in the amount of not less than 10% of the Bid price shall accompany each Bid in accordance with the Instructions to Bidders.

**CONTRACT SECURITY:** The Bidder to whom a Contract is awarded shall furnish a Performance Bond and a Payment Bond each in an amount equal to the Contract Price.

**BID REJECTION/ACCEPTANCE:** The awarding authority for this Contract is the Village Board of The Village of Antioch, and reserves the right to reject any and all Bids, waive informalities in bidding, or to accept the Bid or Bids, which best serve the interests of the OWNER.

**BID WITHDRAWAL:** No Bid shall be withdrawn for a period of 60 days after the scheduled opening of the bids without the consent of OWNER.
