WHEREAS, The 2014 season began in July and finished at the Illinois Recreational Cheerleading Association (IRCA) State Championship on December 7, 2014; and

WHEREAS, the Varsity Cheerleaders received two bids to the State Competition by placing first against all 8th grade medium squads, with the team scoring higher in one competition than any other team at every level of that competition; and

WHEREAS, the season was challenging with 5 different reconfigurations needed and one injury that impacted the entire team; and

WHEREAS, through adversity, the talent of the team shone through with back handsprings, back and full tucks on a non-spring floor, stunting and executing advanced jumps; and

WHEREAS, Vikings Varsity placed second out of thirteen teams during the first round of the state championship held at the Sears Centre in Hofmann Estates during the weekend of December 5, 2014; and


