ORDINANCE NO. 10-02-02

AN ORDINANCE AMENDING THE LIST OF DESIGNATED AUTHORIZED FINANCIAL DEPOSITORIES FOR THE VILLAGE OF ANTIOCH

WHEREAS, in accordance with the Illinois Compiled State Statutes, Ordinance No. 06-10-38 was approved by the Village Board on October 16, 2006, revising Ordinance No. 86-12-30, and designating authorized financial depositories for the Village of Antioch; and

WHEREAS, the current list of designated depositories list requires updating to reflect the current official names of the institutions, and

WHEREAS, the addition of the following institutions will add greater investment security and diversity to the current designated depository options:

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF ANTIOCH as follows:

SECTION IV: All ordinances and parts of ordinances in conflict herewith are hereby repealed.






CERTIFICATE
