**ORDINANCE 10-03-06**

**AN ORDINANCE AMENDING §4-1-7  
OF THE MUNICIPAL CODE OF ANTIOCH  
REVISING THE TERM OF ANNUAL BUSINESS LICENSES**

**WHEREAS**, the Village Board recently adopted a completely revised Liquor Control Ordinance, and

**WHEREAS**, the terms of that Ordinance provide that the liquor licenses are issued annually, taking effect on June 1 of each year and ending on May 31 of the following year, and

**WHEREAS**, the other business licenses, including the ones for operating restaurants and selling food currently have varying effective dates throughout the year, and

**WHEREAS**, administration of all the various licenses will be greatly simplified if all of the annually issued licenses were issued for the same term, and

**WHEREAS**, the possibility of confusion by local businesses as to the terms of their licenses would also be lessened if all of them were issued for the same term,

**NOW THEREFORE, BE IT ORDAINED** by the Village of Antioch, Lake County, Illinois, as follows:

**SECTION ONE:** Section 4-1-7 A of the Antioch Municipal Code is hereby amended and shall hereafter read as follows:

- A. All annual business licenses, including liquor licenses, vending machine licenses and video licenses, shall terminate on May 31 of each year and their renewals shall commence on June 1 of each year.

**SECTION TWO:** Section 4-3-2 B 4 of the Antioch Municipal Code (dealing with coin operated amusement devices) is hereby amended and shall read as follows:

4. Term: See Section 4-1-7 A of this Code.

**SECTION THREE:** Section 4-3-3 B 2 of the Antioch Municipal Code (dealing with pool tables) is hereby amended and shall hereafter read as follows:

2. Term: See Section 4-1-7 A of this Code. All license fees shall be due and payable in advance of the license term.

**SECTION FOUR:** Section 4-3-4 C of the Antioch Municipal Code (dealing with motion picture exhibition) is hereby amended and shall hereafter read as follows:

- C. A license fee in the amount of twenty-five dollars (\$25.00) per year shall be due and payable in advance of the license term. Term: See Section 4-1-7 A of this Code.

**SECTION FIVE:** Section 4-6-1 B 5 of the Antioch Municipal Code (dealing with food dealers) is hereby amended and shall hereafter read as follows:

5. Term: See Section 4-1-7 A of this Code.

**SECTION SIX:** Section 4-9-5 B 1 of the Antioch Municipal Code (dealing with adult uses) is hereby amended and shall hereafter read as follows:

1. Each license shall expire at midnight on the May 31<sup>st</sup> next following the date of its issuance and may be renewed only by making application as provided in Section 4-9-4 of this chapter. Application for renewal shall be made at least thirty (30) days before the expiration date, and when made less than thirty (30) days before the expiration date, the expiration of the license will not be affected.

**SECTION SEVEN:** In order to accommodate the change-over to a new license term, the business licenses that are in effect on the effective date of this amendatory ordinance and that are due to expire on April 30, 2010 shall remain in effect until May 31, 2010, subject to all other terms and conditions of the licenses and the right of the Village to revoke, suspend or take other action for just cause in appropriate cases at no further expense to the licensee.

**SECTION EIGHT:** Similarly, in order to accommodate the change-over, the business licenses that are in effect on the effective date of this amendatory ordinance and that are due to expire after May 31, 2010 shall remain in effect until May 31, 2011, subject to all other terms and conditions of the licenses and the right of the Village to revoke, suspend or take other action for just cause in appropriate cases, and the license fees shall due on May 31, 2011 shall be increased by a pro rata amount to cover the extension of the licenses from their prior termination date to the termination date established hereby.


**SECTION NINE:** This Ordinance shall be in full force and effect from and after its passage, approval and publication as required by law.
