ORDINANCE NO. 10-05-18

AN ORDINANCE AMENDING §4-2B-14 OF THE MUNICIPAL CODE OF ANTIOCH
CHANGING THE NUMBER OF CLASS C LICENSES FROM 8 TO 7 AND
ALSO CHANGING THE NUMBER OF CLASS D LICENSES FROM 2 TO 3

WHEREAS, the Village recently adopted a completely revised liquor code, and following the adoption of that code, one technical error in implementation of the same has arisen which the Board finds requires one minor amendment, and

WHEREAS, the said amendment is to correct a counting error in the number of Class C and D licenses to reflect the actual number of such licensees existing at the time of implementation of the revised code, and

NOW THEREFORE, BE IT ORDAINED by the Village of Antioch, Lake County, Illinois, as follows:

SECTION ONE: The fee chart set forth in Section 4-2B-14 of the Antioch Municipal Code is hereby amended by changing the number of Class C licenses from 8 to 7 and also changing the number of Class D licenses from 2 to 3.

SECTION TWO: This Ordinance shall be in full force and effect from and after its passage, approval and publication as required by law.
