ORDINANCE NO. 10-06-21

AN ORDINANCE AMENDING §4-2B-10 OF THE MUNICIPAL CODE OF ANTIOCH EXPANDING WINE SHOP SALES TO INCLUDE BEERS

WHEREAS, the Village recently adopted a completely revised liquor code, and

WHEREAS, the current holder of the only E2 license in the Village wishes to expand its offering of wines to include a range of beers in order to more effectively compete in the marketplace, and

WHEREAS, the Village Board wishes to encourage competition and the offering of a larger variety of business opportunities and entertainment options available within the Village, and accordingly finds that the proposed modification is appropriate,

NOW THEREFORE, BE IT ORDAINED by the Village of Antioch, Lake County, Illinois, as follows:

SECTION ONE: Section 4-2B-10 of the Antioch Municipal Code is hereby amended and it shall hereafter read as follows (additions <u>underlined</u>, deletions in strikeout):

4-2B-10: CLASSIFICATION OF LICENSES:

* * *

E-2. Class E-2: Wine shop license. This license is equivalent to a Class E license in all respects, except that the alcoholic products that may be sold or offered for tasting or sampling are strictly limited to wines <u>and beers</u>.

SECTION TWO: This Ordinance shall be in full force and effect from and after its passage, approval and publication as required by law.
