ORDINANCE NO. 10-10-26

AN ORDINANCE AMENDING §4-2B-14 OF THE MUNICIPAL CODE OF ANTIOCH ADDING ONE MORE CLASS E LICENSE

WHEREAS, the Village Board has been approached by a local entrepreneur who wishes to open a new tavern in town in the plaza by the train station, together with an outside service area, and

WHEREAS, the Village Board has considered the application and has determined that the proposal is appropriate for the suggested location and type of business, and it is an appropriate designated licensee, and

WHEREAS, the Village Board wishes to expand business opportunities wherever possible, for the overall benefit of the citizens and taxpayers of this Village,

NOW THEREFORE, BE IT ORDAINED by the Village of Antioch, Lake County, Illinois, as follows:

SECTION ONE: Section 4-2B-14 of the Antioch Municipal Code is hereby amended by revision of the chart of allowed liquor licenses to increase the number of Class E licenses from 4 to 5 and the number of class E-1 licenses from 3 to 4.

SECTION TWO: This Ordinance shall be in full force and effect from and after its passage, approval and publication as required by law.
