MINUTES of the regular public meeting of the Mayor and Board of Trustees of the Village of Antioch, Lake County, Illinois held at the Village Hall, 874 Main Street, in said Village on the 5 day of December, 2011.

The Mayor called the meeting to order and directed the Village Clerk to call the roll. Upon the roll being called, the following Trustees answered present: Pierce, Sakas, Poulos, Crosby, Dominiak and Jozwiak.

The following Trustees were absent from the meeting: None.

The Mayor announced that the next item of business before the Board was the consideration of the adoption of an ordinance abating the tax heretofore levied for the year 2011 to pay the principal and interest on the \$3,000,000 General Obligation Bonds, (Waterworks and Sewerage Revenue Alternate Revenue Source), Series 1998B, dated October 1, 1998; and the \$2,000,000 General Obligation Bonds (Motor Fuel Tax Alternate Revenue Source), Series 2002A, dated October 1, 2002.

Whereupon Trustee Pierce presented and the Village Clerk read in full an ordinance as follows:

**ORDINANCE NO. 11-12-17**

AN ORDINANCE abating the tax heretofore levied for the year 2011 to pay the principal of and interest on the \$3,000,000 General Obligation Bonds, (Waterworks and Sewerage Revenue Alternate Revenue Source), dated October 1, 1998; and the \$2,000,000 General Obligation Bonds (Motor Fuel Tax Alternate Revenue Source), Series 2002A, dated October 1, 2002 of the Village of Antioch, Lake County, Illinois.

WHEREAS, the Mayor and Board of Trustees (the "Corporate Authorities") of the Village of Antioch, Lake County, Illinois (the "Village"), by Ordinances adopted on October 26, 1998 and January 21, 2002 (the "Ordinances"), did provide for the issue of \$3,000,000 General Obligation Bonds (Waterworks and Sewerage Revenue Alternate Revenue Source), Series 1998B, dated October 1, 1998 and the \$2,000,000 General Obligation Bonds (Motor Fuel Tax Alternate Revenue Source) Series 2002A, (the "Bonds"), and the levy of a direct annual tax in each of said ordinances sufficient in an amount to pay the principal of and interest on the Bonds; and

WHEREAS, the Village will have Pledged Revenues (as defined in the Ordinance) derived from sources other than the levy of taxes provided for in the ordinance mentioned above and which funds can be made available for the purpose of paying principal of and interest on said outstanding obligations up to and including June 1, 2013; and

WHEREAS, it is necessary and in the best interests of the Village that the tax heretofore levied in each of said ordinances for the year 2011 to pay the principal of and interest on the Bonds be abated.

NOW THEREFORE, Be It Ordained by the Mayor and Board of Trustees of Village of Antioch, Lake County, Illinois as follows:

Section 1: Abatement of Tax: The tax heretofore levied for the year 2011 in each of the Ordinances adopted October 26, 1998 and January 21, 2002 is hereby abated in its entirety.

Section 2: Filing of Ordinance: Forthwith upon the adoption of this ordinance, the Village Clerk shall file a certified copy hereof with the County Clerk of the County of Lake, Illinois, and it shall be the duty of said Country Clerk to abate said tax levied for the year 2011 in accordance with the provisions hereof.

Section 3: Effective Date: This ordinance shall be in full force and effect forthwith upon its passage by the Corporate Authorities and signing and approval by the Mayor.


