**ORDINANCE NO. 12-06-11**

**AN ORDINANCE AMENDING SEVERAL SECTIONS OF TITLE 4  
CHAPTER 2B OF THE MUNICIPAL CODE OF ANTIOCH  
ADDING A CLASS I "WINERY" LICENSE**

**WHEREAS**, the Village Board has been petitioned by the owners of certain agricultural lands for annexation and development of a small winery upon their property, and

**WHEREAS**, the Village Board has considered the petition and has determined that the proposal is appropriate for the suggested location and type of business, and that the petitioner is an appropriate designated licensee, and

**WHEREAS**, the Village Board wishes to expand business opportunities wherever possible, for the overall benefit of the citizens and taxpayers of this Village, and

**WHEREAS**, this particular proposed development appears to be a highly attractive amenity being added to the assets of the Village, which should assist the Village Board in improving the overall marketability of the Village and in attracting additional tourists and hotel guests,

**NOW THEREFORE, BE IT ORDAINED** by the Village of Antioch, Lake County, Illinois, as follows:

**SECTION ONE:** Section 4-2B-10 of the Antioch Municipal Code is hereby amended by the addition of paragraph I, which shall hereafter read as follows:

Class I: Winery license. This license authorizes the sale of bottled table wines for consumption off premises only. As an adjunct to the sale of such wines, the licensee may sell or provide tastes or samples of the wines, strictly upon the following terms and conditions:

- a) A taste or sample shall consist of no more than one (1) liquid ounce of wine;
- b) Only table wines may be provided for tastes or samples;
- c) No person shall be served more than five (5) tastes or samples of wine in one (1) day;
- d) The licensee shall be permitted to sell wine on premises and/or offer tastes or samples only during the following days and times:

Saturdays, Sundays and Holidays:	10:00 am to 8:00 pm
All other days:	10:00 am to 8:00 pm
- e) All tastes and samples must be offered or provided only inside a building;
- f) The licensee may ship bottled products at other times consistent with its State of Illinois license.

**SECTION TWO:** Section 4-2B-14 of the Antioch Municipal Code is hereby amended by revision of the chart of allowed liquor licenses to add one Class I license.

**SECTION THREE:** Section 4-2B-11(A)(2) is hereby amended by the revision of the chart of license fees to add a Class I license at an annual fee of \$2,000.00 for the years 2012 and thereafter.

**SECTION FOUR:** This Ordinance shall be in full force and effect from and after its passage, approval and publication as required by law.
