**ORDINANCE 12-12-31**

**AN ORDINANCE AMENDING §4-2B-14 OF THE MUNICIPAL CODE OF ANTIOCH  
ADDING ONE MORE CLASS C LICENSE**

**WHEREAS**, the Village Board has been approached by Aldi, Inc., which is in the process of building a new grocery store on the corner of Illinois Route 173 and Deep Lake Road, and in particular, Aldi, Inc., has asked that it be granted an additional Class C liquor license which will allow it to conduct package sales of alcoholic products, and

**WHEREAS**, the Village Board has considered the application and has determined that the proposal is appropriate for the suggested location and type of business, and it is an appropriate designated licensee, and

**WHEREAS**, the Village Board wishes to expand business opportunities wherever possible, for the overall benefit of the citizens and taxpayers of this Village,

**NOW THEREFORE, BE IT ORDAINED** by the Village of Antioch, Lake County, Illinois, as follows:

**SECTION ONE:** Section 4-2B-14 of the Antioch Municipal Code is hereby amended by revision of the chart of allowed liquor licenses to increase the number of Class C licenses from 8 to 9, effective at such time as the new Aldi store is granted a certificate of occupancy from the Antioch Building Department.

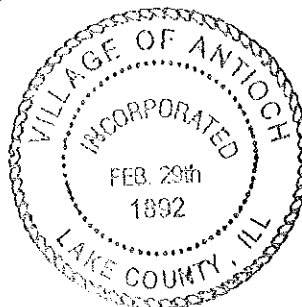
**SECTION TWO:** This Ordinance shall be in full force and effect from and after its passage, approval and publication as required by law.
