ORDINANCE 12-12-32

AN ORDINANCE AMENDING §4-2B-14 OF THE MUNICIPAL CODE OF ANTIOCH ADDING ONE MORE CLASS B AND SUBSIDIARY B-1 LICENSE

WHEREAS, the Village Board has been approached by the owners of the Mere Café who have recently opened a new restaurant in an historic building on the corner of Illinois Route 173 and Main Street, and in particular, these owners asked that they be granted an additional Class B liquor license which will allow it to conduct restaurant sales of alcoholic products, and

WHEREAS, the said owners have further requested that they be granted an additional Class B-1 liquor license, which will allow it to establish an outdoor café service area, and

WHEREAS, the Village Board has considered the application and has determined that the proposal is appropriate for the suggested location and type of business, and it is an appropriate designated licensee, and

WHEREAS, the Village Board wishes to expand business opportunities wherever possible, for the overall benefit of the citizens and taxpayers of this Village,

NOW THEREFORE, BE IT ORDAINED by the Village of Antioch, Lake County, Illinois, as follows:

SECTION ONE: Section 4-2B-14 of the Antioch Municipal Code is hereby amended by revision of the chart of allowed liquor licenses to increase the number of Class B licenses from 0 to 1 and the Class B-1 licenses from 0 to 1, effective immediately.

SECTION TWO: This Ordinance shall be in full force and effect from and after its passage, approval and publication as required by law.
