ORDINANCE 12-12-33

AN ORDINANCE AMENDING §4-2B-14 OF THE MUNICIPAL CODE OF ANTIOCH PROVIDING FOR THE CLERK TO MAINTAIN AN OFFICIAL LIST OF LICENSES AND PROVIDING FOR THE AUTOMATIC VOIDING OF LAPSED OR REVOKED LICENSES

WHEREAS, the various establishments that hold liquor licenses occasionally open, close and are sold, and they are subject to the potential application of the revocation provisions of the Illinois Liquor Control Act of 1934, as amended, (the Act) and the companion revocation provisions of the Antioch Municipal Code, and

WHEREAS, it is the policy of the Village Board to maintain the strictest possible control over the number of liquor licenses that are issued so that no excess, unused licenses remain available, and

WHEREAS, there are a comparatively rare set of circumstances by which licenses may lapse or may be revoked, and

WHEREAS, the Village Board wishes to provide that such lapsed or revoked licenses are automatically voided so as to limit any attempt to establish a new liquor-related business without full public debate to the maximum extent permissible under the Act, and

WHEREAS, in order to provide for such a structural revision to the existing code, the chart of authorized licenses must be removed from the Antioch Municipal Code and the Clerk empowered to maintain such a chart and report on a timely basis to the Village Board for any changes required to be made thereto as a result of any such automatic voidance,

NOW THEREFORE, BE IT ORDAINED by the Village of Antioch, Lake County, Illinois, as follows:

SECTION ONE: Section 4-2B-14 of the Antioch Municipal Code is hereby amended in its entirety, and it shall hereafter read as follows (additions <u>underlined</u>, deletions in strikeout):

4-2B-14: NUMBER OF LICENSES:

The following is This section provides for the maximum number of licenses that may be issued for each class. These numbers may be amended only by the board of trustees:

A.The following chart shows the number of licenses that are currently authorized pursuant to ordinances duly passed by the Village Board prior to the adoption of an amendatory ordinance on December 17, 2012:

- B. From and after the adoption of the amendatory ordinance on December 17, 2012, the Village Clerk, serving as the administrative assistant to the Liquor Commissioner, shall maintain a current list of all authorized licenses, and shall report to the Village Board promptly at any time there is any change in the number of such licenses, irrespective of the reason for the change.
- C. In the event any license(s) shall be revoked by final administrative action of the Liquor Commissioner, and any appeals to the Illinois Liquor Commission or the courts of this state shall have been exhausted, such license(s) shall be automatically void and the Village Clerk shall decrease the number of authorized licenses by the number of such revoked license(s).
- D. In the event any license(s) shall be allowed to lapse through non-renewal, relinquishment or otherwise, such license(s) shall be automatically void and the Village Clerk shall decrease the number of authorized licenses by the number of such revoked license(s).

SECTION TWO: This Ordinance shall be in full force and effect from and after its passage, approval and publication as required by law.
