ORDINANCE 13-01-01

AN ORDINANCE AMENDING §7-3-1 OF THE MUNICIPAL CODE OF ANTIOCH PROHIBITING PARKING IN THE AREA OF THE INTERSECTION OF TIFFANY AND ROUTE 173

WHEREAS, the State of Illinois, through the Illinois Department of Transportation (IDOT), is desirous of improving the intersection of Tiffany Road and Illinois Route 173 to improve safety and ease the flow of traffic through new and reconstructed roadbeds and pavement, as well as the installation of traffic signals, and

WHEREAS, IDOT has required that parking of motor vehicles be prohibited within the area being improved, as an additional safety requirement, and the Village Board finds that such a prohibition will materially improve safety and ease the flow of traffic, and

WHEREAS, portions of Lake Street, Tiffany and Illinois Route 173 are within the designated project area, and

WHEREAS, the Antioch Municipal Code regulates or prohibits parking in designated areas therein, and amending the provisions of Section 7-3-1 of the said code will effectuate the prohibitions required by IDOT, in a manner readily understandable and enforceable by the Police Department, and

WHEREAS, during the preparation of this draft ordinance, it was noticed that there is currently no ban on parking on the section of Tiffany Road north of the project site, and the Village Board finds that such a ban must be included in the ordinance as the roadway is heavily traveled and is too narrow to provide proper space for parking,

NOW THEREFORE, BE IT ORDAINED by the Village of Antioch, Lake County, Illinois, as follows:

SECTION ONE: The chart of prohibited parking zones set forth in Section 7-3-1B of the Antioch Municipal Code is hereby amended and shall hereafter read as follows (additions underlined, deletions ~~stricken~~):


Harden Street	Either	Spafford Street and Hillside Avenue.

Hillside Avenue	Either	Orchard Street to Depot Street.
Hillside Avenue	Either	State Route 59 and State Route 173, the northerly side of Hennings Court running easterly and westerly, west side of Hennings Court running northerly and southerly.
Illinois Route 173	Either	<u>Entire length of route within Village limits.</u>
Illinois Route 173	—	Illinois Route 83 and the eastern village limits.
Illinois Route 173	—	Route 59 and Route 83.
Lake Street	North	Hillside Avenue and St. Peter Street.
Lake Street	North	Toft Avenue and Hillside Avenue.
Lake Street	North	Toft Avenue to Tiffany Road.
Lake Street	North	West curb of St. Peter Street and a point 100 feet west thereof.
Lake Street	South	East access drive of the State Bank of the Lakes (440 Lake Street) property to Tiffany Road.

Main Street	East	State Route 173 and north limits of high school property.
North Main Street	West	Depot Street and north limits of grade school property.


SECTION TWO: This Ordinance shall be in full force and effect from and after its passage, approval and publication as required by law.
