ORDINANCE 13-1-03

AN ORDINANCE PROHIBITING ENCROACHMENTS IN THE STATE OF ILLINOIS RIGHT OF WAY ALONG ILLINOIS ROUTE 173

WHEREAS, the State of Illinois acting by and through its Department of Transportation, is desirous of improving Illinois Route 173 between Route 59 and Sequoit Creek in the Village of Antioch; and

WHEREAS, said project is being constructed in order to facilitate the free flow of traffic and ensure safety to the motoring public;

NOW THEREFORE, BE IT ORDAINED by the Village of Antioch, Lake County, Illinois, as follows:

SECTION ONE: That no person, firm, corporation or other entity shall install, place, maintain or construct any structure that encroaches upon the State of Illinois right of way on Illinois Route 173 within the corporate limits of the Village of Antioch.

SECTION TWO: The Clerk of the Village of Antioch is hereby authorized and directed to attach a copy of this Ordinance to the agreement dated January 30, 2013, by and between the State of Illinois and the Village of Antioch relative to the improvement of the said section of Illinois Route 173.

SECTION THREE: This Ordinance shall be in full force and effect from and after its passage, approval and publication as required by law.
