**ORDINANCE 13-04-05**

**AN ORDINANCE ADDING ONE MORE CLASS B LIQUOR LICENSE  
FOR A NEW RESTAURANT KNOWN AS BETTY'S BISTRO**

**WHEREAS,** the Village Board has been petitioned by the corporate owner of the Betty's Bistro restaurant chain who have announced an intention to open a new restaurant in an existing building in the outlying structures in front of the Walmart and the Menard's businesses on Illinois Route 173, and in particular, these owners asked that they be granted an additional Class B liquor license which will allow it to conduct indoor table service restaurant sales of beer and wine, and

**WHEREAS,** the Village Board has considered the application and has determined that the proposal is appropriate for the suggested location and type of business, and it is an appropriate designated licensee, and

**WHEREAS,** the Village Board wishes to expand business opportunities wherever possible, for the overall benefit of the citizens and taxpayers of this Village,

**NOW THEREFORE, BE IT ORDAINED** by the Village of Antioch, Lake County, Illinois, as follows:

**SECTION ONE:** The Village Clerk, acting as the Secretary of the Local Liquor Commissioner is directed to revise the chart of allowed liquor licenses to increase the number of Class B licenses by 1 effective at such time as Betty's Bistro has secured a certificate of occupancy for the proposed restaurant.

**SECTION TWO:** This Ordinance shall be in full force and effect from and after its passage, approval and publication as required by law.

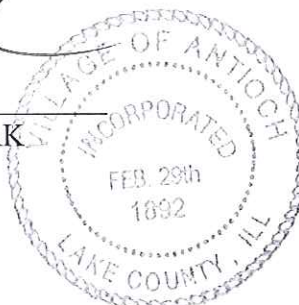
