**ORDINANCE 13-04-06**

**AN ORDINANCE AMENDING §7-3-1 OF THE MUNICIPAL CODE OF ANTIOCH  
PROHIBITING PARKING ON SEVERAL DOWNTOWN STREETS**

**WHEREAS,** Staff has advised the Village Board of vehicle parking problems that have recently arisen in the areas of Naber, Hillside, and Osmond between Illinois Route 173 and Lake Street, and

**WHEREAS,** the Village Board finds that it is necessary to adopt a carefully tailored partial prohibition of parking in this area to ensure the safety of citizens and business patrons and to ease the flow of traffic, and

**NOW THEREFORE, BE IT ORDAINED** by the Village of Antioch, Lake County, Illinois, as follows:

**SECTION ONE:** The chart of prohibited parking zones set forth in Section 7-3-1B of the Antioch Municipal Code is hereby amended by the addition of the following line items:


<u>Street</u>	<u>Side</u>	<u>Between</u>
Hillside Avenue	East	Lake Street and Illinois Route 173.
Naber Street	Either	Osmond Street and Hillside.


**SECTION TWO:** This Ordinance shall be in full force and effect from and after its passage, approval and publication as required by law.
