ORDINANCE 13-05-07

**AN ORDINANCE ADDING ONE CLASS E LIQUOR LICENSE
FOR A NEW ESTABLISHMENT KNOWN AS
THE LAST STOP TAVERN**

WHEREAS, the Village Board has been petitioned by the developer of a proposed new bar in an existing building on Depot Street near the train station, which has been a site occupied by bars and taverns for a number of years, and in particular, these owners asked that they be granted an additional Class E liquor license which will allow it to conduct tavern sales of alcoholic drinks at its bar, and

WHEREAS, the Village Board has considered the application and has determined that the proposal is appropriate for the suggested location and type of business, and it is an appropriate designated licensee, and

WHEREAS, the Village Board wishes to expand business opportunities wherever possible, for the overall benefit of the citizens and taxpayers of this Village,

NOW THEREFORE, BE IT ORDAINED by the Village of Antioch, Lake County, Illinois, as follows:

SECTION ONE: The Village Clerk, acting as the Secretary of the Local Liquor Commissioner is directed to revise the chart of allowed liquor licenses to increase the number of Class E licenses by 1 effective at such time as The Last Stop Tavern has completed the application process and secured a certificate of occupancy for the proposed tavern.


SECTION TWO: This Ordinance shall be in full force and effect from and after its passage, approval and publication as required by law.
