ORDINANCE 13-05-08

**AN ORDINANCE CREATING ONE ADDITIONAL CLASS A-1 LICENSE
FOR WINGS ETC.**

WHEREAS, the Village Board was petitioned by the owners of Wings Etc., being a duly licensed establishment currently holding a class A license at its facility at 480 Orchard Street, and

WHEREAS, the owners of Wings, Etc. will offer seating, tables and other amenities consistent with and in addition to similar outdoor seating that is currently serving as an amenity at several other establishments in downtown Antioch, and

WHEREAS, the Village Board wishes to encourage competition and the offering of a larger variety of business opportunities and entertainment options available within the Village, and accordingly finds that the proposed grant of an additional A-1 outdoor service license is appropriate in these circumstances,

NOW THEREFORE, BE IT ORDAINED by the Village of Antioch, Lake County, Illinois, as follows:

SECTION ONE: The Village Clerk, acting as the Secretary of the Local Liquor Commissioner is directed to revise the chart of allowed liquor licenses to increase the number of Class A-1 licenses by 1 for Wings Etc.

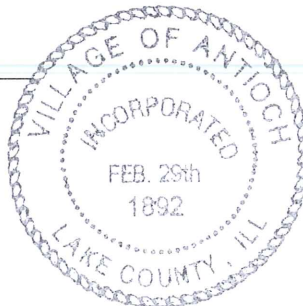
SECTION TWO: This Ordinance shall be in full force and effect from and after its passage, approval and publication as required by law.
