ORDINANCE 13-08-17

AN ORDINANCE AMENDING §12-1-1 OF THE MUNICIPAL CODE OF ANTIOCH

WHEREAS, the Federal Emergency Management Agency (FEMA) has notified the Village along with all other municipalities in Lake County that a condition of maintaining full eligibility for flood insurance is adopting regulations involving construction within wetlands areas that meet or exceed the provisions of paragraph 60.3(d) of the National Flood Insurance Program (NFIP), including the adoption of the most current Flood Insurance Rate Map (FIRM) applicable to the Village's territory, and

WHEREAS, the corporate authorities find that taking the appropriate steps to maintain the broadest availability of flood insurance and the lowest possible rates is in the best interests of the residents and property owners within the Village, and

WHEREAS, the Village has previously adopted the Lake County Watershed Development Ordinance (WDO) by reference, which ordinance includes certain regulations dealing with construction and related matters within floodplains, floodways and other wetlands, and

WHEREAS, the corporate authorities find that it is appropriate to adopt by reference the provisions of paragraph 60.3(d) of the NFIP, and its attendant FIRM as the minimum regulations involving construction and structures within wetlands areas, understanding that the more restrictive regulations of the WDO may set higher standards within various project sites

NOW THEREFORE, BE IT ORDAINED by the Village of Antioch, Lake County, Illinois, as follows:

SECTION ONE: Section 12-1-1C of the Antioch Municipal Code is hereby amended and shall hereafter read as follows (additions <u>underlined</u>, deletions <u>stricken</u>):

12-1-1: REGULATIONS ADOPTED:

* * *

C. Floodplain Regulations: Floodplain regulations are contained within the Lake County watershed development ordinance adopted by reference in subsection A of this section. Additionally, the regulations of the National Flood Insurance Program, paragraph 60.3(d) and the local Flood Insurance Rate Map panels attached as Exhibit A hereto are hereby adopted by reference. In the event of a conflict between the provisions of the foregoing adopted sets of regulations, the more restrictive regulation shall be deemed to be applicable.

SECTION TWO: This Ordinance shall be in full force and effect from and after its passage, approval and publication as required by law.
