**ORDINANCE 14-04-07**

**AN ORDINANCE AMENDING SECTION 4-2B-10  
OF THE MUNICIPAL CODE OF ANTIOCH  
MODIFYING THE CLASS “C” PACKAGE LICENSE REGULATIONS**

**WHEREAS**, the Village Board has been petitioned by the owners of a large package goods store seeking the opportunity to expand their current sampling options to include sales for on-site consumption of limited edition or expensive wines, craft beers and spirits, and

**WHEREAS**, the Village Board has considered the petition and has determined that the proposal is appropriate for the suggested location and type of business, and that the petitioner is an appropriate designated licensee, having been in operation with an exemplary record of compliance with the liquor laws for many years, and

**WHEREAS**, the Village Board wishes to expand business opportunities wherever possible, for the overall benefit of the citizens and taxpayers of this Village, and

**WHEREAS**, this particular proposal appears to be a highly attractive amenity being added to the assets of the Village, which should assist the Village Board in improving the overall marketability of the Village and in attracting additional tourists and hotel guests,

**NOW THEREFORE, BE IT ORDAINED** by the Village of Antioch, Lake County, Illinois, as follows:

**SECTION ONE:** Section 4-2B-10 of the Antioch Municipal Code is hereby amended by the amendment of the existing paragraph C, which shall hereafter read as follows (additions underlined, deletions ~~stricken~~):

C. Class C: Retail package sales. This license authorizes the retail sale of alcoholic liquors, in original package form, for consumption off the premises where sold. This license shall further authorize "sampling" ~~and~~, "tasting", and "expanded sampling" of alcoholic beverages strictly in accordance with the following definitions:

**SAMPLING:** A product sample, offered in connection with a sales promotion, consisting of no more than the following amounts: distilled spirits one-fourth (1/4) ounce, wine one ounce, beer two (2) ounces. Only products registered with the state liquor commission may be sampled.

**TASTING:** A supervised presentation of alcoholic products to the public for the purpose of disseminating product information and education, with consumption of alcoholic products being an incidental part thereof. Only products registered with the state liquor commission may be tasted in the following amounts: distilled spirits one-fourth (1/4) ounce, wine one ounce, beer two (2) ounces. Notice of tasting may be advertised. Tasting must be supervised by the licensee and/or an authorized representative of the licensee.

EXPANDED SAMPLING: Due to the fact that certain wines, liquors and craft beers are highly expensive and/or are available only in very limited quantities sporadically, rendering them difficult to market, larger package goods stores shall be permitted to engage in expanded sampling as follows:

- A) Expanded sampling is available only to packaged liquor stores of not less than 15,000 square feet in sales floor;
- B) Sales by expanded sampling shall not exceed more than 2% by dollar value of all store sales;
- C) Products dispensed under this classification may be sold for consumption on premises, provided that not more than 32 ounces of any craft beer, 4 ounces of any spirit or 12 ounces of any wine may be sold to any customer in any one sales session;
- D) Due to the unique nature of such sales, this license shall not be deemed a "pouring license" that authorizes or allows the store to install or operate any video gaming. In the unanticipated event the State Gaming Board determines that such a license does authorize video gaming, this license shall become null and void.

**SECTION TWO:** Section 4-2B-11 of the Antioch Municipal Code is hereby amended by the addition of the following paragraph c, which shall hereafter read as follows:

c. Package goods stores qualifying for and engaging in expanded sampling as permitted by Class C licenses shall pay an additional \$250 annual fee to the Village as a condition of that specifically limited sales opportunity.

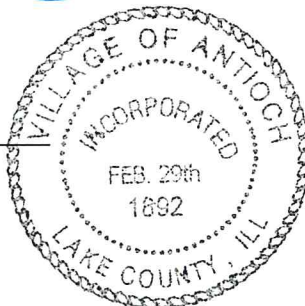
**SECTION THREE:** This Ordinance shall be in full force and effect from and after its passage, approval and publication as required by law.


**CERTIFICATE**
