ORDINANCE 14-07-13

**AN ORDINANCE AMENDING SECTION 4-2B-10
OF THE MUNICIPAL CODE OF ANTIOCH
MODIFYING THE CLASS "I" WINERY LICENSE REGULATIONS**

WHEREAS, the Village Board has been petitioned by the owners of Vigneto del Bino Winery seeking the opportunity to expand their current sampling options to include on-site consumption and increased tastes or samples of wine in one day, and

WHEREAS, the Village Board has considered the petition and has determined that the proposal is appropriate for the suggested location and type of business, and that the petitioner is an appropriate designated licensee, having been in operation with a record of compliance with the liquor laws, and

WHEREAS, the Village Board wishes to expand business opportunities wherever possible, for the overall benefit of the citizens and taxpayers of this Village, and

WHEREAS, this particular proposal appears to be a highly attractive amenity being added to the assets of the Village, which should assist the Village Board in improving the overall marketability of the Village and in attracting additional tourists and hotel guests,

NOW THEREFORE, BE IT ORDAINED by the Village of Antioch, Lake County, Illinois, as follows:

SECTION ONE: Section 4-2B-10 of the Antioch Municipal Code is hereby amended by the amendment of the existing paragraph I, which shall hereafter read as follows (additions underlined, deletions ~~stricken~~):

I. Class I: Winery license. This license authorizes the sale of bottled table wines for consumption on or off premises only. The licensee may sell wine for consumption on the premises by the glass, in smaller samples commonly known as "flights" or by the bottle at the serving table or bar. ~~As an adjunct to the sale of such wines, the licensee may sell or provide tastes or samples of the wines, strictly upon the following terms and conditions:~~

- ~~1. A taste or sample shall consist of no more than one liquid ounce of wine;~~
- ~~2. Only table wines may be provided for tastes or samples;~~
- ~~3. No person shall be served more than five (5) tastes or samples of wine in one day;~~
4. The licensee shall be permitted to sell wine on premises and/or offer tastes or samples only during the following days and times:

Saturdays, Sundays and holidays	10:00 A.M. to 8:00 P.M.
All other days	10:00 A.M. to 8:00 P.M.

5. All tastes and samples must be offered or provided only inside a building;
6. The licensee may ship bottled products at other times consistent with its state of Illinois license. (Ord. 12-06-11, 6-18-2012)

7. The winery is authorized to permit a patron to remove one unsealed and partially consumed bottle of wine for off premises consumption. A partially consumed bottle of wine that is to be removed from the premises shall be securely sealed by the licensee or an agent of the licensee prior to removal from the premises, and placed in a transparent, one-time use, tamperproof bag. Before any patron may leave the premises with his/her/their previously opened bottle, an explanation of applicable traffic laws shall be given.

SECTION TWO: This Ordinance shall be in full force and effect from and after its passage, approval and publication as required by law.
