ORDINANCE 14-08-17

AN ORDINANCE AMENDING CHAPTER 7-3 OF THE MUNICIPAL CODE OF ANTIOCH PROHIBITING PARKING OF LARGE TRUCKS IN RESIDENTIAL AREAS

WHEREAS, the Village Board is charged with the responsibility to oversee the local roads owned and maintained by the Village, and to establish reasonable rules providing for public safety and the peaceful enjoyment of properties within the Village, and

WHEREAS, the Village Board finds that parking of large vehicles on residential roads has become a nuisance in several areas of the municipality, creating hazards for motorists, pedestrians and children, as well as noxious sources of noise and diesel smoke and soot, and

WHEREAS, the Illinois license classification system provides that certain vehicles have the license plate classifications shown on the attached exhibit, and

WHEREAS, the Village Board finds that adding a provision which specifically prohibits parking of vehicles other than those with class "A", "B", "C", "D", "TX", "PT", "LI", "M" and "RV" license plates on those same roads is a necessary and parallel step that should be taken in order to further improve the safety and harmony of the public, and

WHEREAS, the Village Board further finds that adding a provision which specifically prohibits parking of trailers other than those with class "TA", "TB", "TC" and "TD" license plates on on those same roads is a necessary and parallel step that should be taken in order to further improve the safety and harmony of the public, while still preserving the opportunity for people with common boat or camping trailers to park when necessary, and

NOW THEREFORE, BE IT ORDAINED by the Village of Antioch, Lake County, Illinois, as follows:

SECTION ONE: Chapter 7-3 of the Antioch Municipal Code is hereby amended by the addition of the following section 17, which shall hereafter read as follows:

7-3-17: TRUCK ROUTES:

A. Certain roads within the village are, by their location, design and construction, amenable to vehicular traffic including heavy and/or large trucks and trailers, whereas other local roads are not capable of accommodating these vehicles safely, and the roads could be unduly damaged by such traffic. Additionally, many of the residential roads and smaller commercial roads are not wide enough to safely accommodate parking of larger trucks and trailers and often larger trucks are powered with correspondingly large engines which make a lot more noise and can disturb the peace of neighborhoods. For these

reasons, the village finds it necessary to prohibit parking of large trucks and trailers on any roads other than those specifically designated hereinbelow in subsection B.

B. It is prohibited to park vehicle bearing vehicle license plates other than class "A", "B", "C", "D", "TX", "PT", "LI", "M" and "RV", or any trailer bearing license plates other than class "TB", "TC" and "TD" on any village street other than upon the following roads, which are hereby designated as truck routes:

Anita Street

Bartlett Avenue

Bishop Street (south of Chestnut only)

Chestnut Street

Deep Lake Road (County Highway 36)

Drom Court

Dwight Court

Gail Street

Highview Drive

Hillside Avenue (between Route 173 and West Depot Street only)

Holbeck Drive

Ida (between Gail and Bartlett)

IDI Drive

Kairy Street

Lake Street

McMillen Road

Nelson Road

North Avenue (County Highway A2)

Orchard Street

Pickard Avenue

Railroad Avenue

Ram Road

Savage Road

Sequoit Avenue

State Highways 173, 83 and 59

Tiffany Road

Toft Avenue

Trevor Road

West Depot Street (between Hillside and Holbeck only)

Williams (between Route 83 and Pickard)

C. The provisions of this section shall not apply to school buses or garbage trucks while in the course of routine pick ups, nor shall they apply to vehicles making local deliveries, such as postal vehicles, express delivery vehicles, moving vans, construction vehicles working on local construction projects and the like.

- D. For the purposes of this section, the words "parking" or "park" shall include stopping a motor vehicle alongside a public road, whether the wheels of the vehicle are actually on the pavement or only on the shoulder or curb.
- E. Nothing herein shall allow operations of any vehicle in violation of the truck route regulations established by section 7-3-16 of this Code.
- F. Refer to 1-3-1A of this Code for a schedule of fines applicable to violations of this section.

SECTION TWO: Section 1-3-1A of the Antioch Municipal Code is hereby amended by the addition of a penalty provision relating to violations of section 7-3-17 of this code and it shall hereafter read as follows:

SECTION THREE: This Ordinance shall be in full force and effect from and after its passage, approval and publication as required by law.
