ORDINANCE 14-08-18

AN ORDINANCE AMENDING SECTION 4-2B-10 OF THE MUNICIPAL CODE OF ANTIOCH ALLOWING THE TRANSFER OF THE CLASS "C" SHOP 'N SAVE LICENSE FROM THE SHRIJI GROUP LLC TO AMBICA ENTERPRISE, INC.

WHEREAS, the Village Board has been petitioned by Ambica Enterprise, Inc. who are interested in purchasing the Shop N Save business located at 579 W. Route 173, and

WHEREAS, the Village Board has considered the petition and has determined that the proposal is appropriate for the transfer of business, and

WHEREAS, the Antioch Liquor Code provides that liquor licenses are decremented when relinquished and are not transferrable as a matter of right, and

WHEREAS, the Village Board wishes to expand business opportunities wherever possible, for the overall benefit of the citizens and taxpayers of this Village, and

NOW THEREFORE, BE IT ORDAINED by the Village of Antioch, Lake County, Illinois, as follows:

SECTION ONE: The Village Clerk, acting as the Secretary of the Local Liquor Commissioner, is directed to revise the chart of allowed liquor licenses as necessary to allow Shriji Group, LLC to relinquish its existing license, and to reissue the same to Ambica Enterprise, Inc.

SECTION TWO: The fee and application process as required for all new and existing businesses will be completed, and no license shall be issued until all requirements are met by the applicant.

SECTION TWO: This Ordinance shall be in full force and effect from and after its passage, approval and publication as required by law.
