### ORDINANCE 14-08-19

# AN ORDINANCE AMENDING CHAPTER 2-3 OF THE MUNICIPAL CODE OF ANTIOCH PROVIDING FOR ALTERNATE MEMBERS OF THE PARK BOARD

WHEREAS, the Village has long had a Park Commission which has been charged with providing suggestions on park management and coordination of activities to the Village Board and to assist in other park and program improvements over the years, and

WHEREAS, the Park Commission has had a long history of success in its endeavors, which is a reflection of the dedication of the people selflessly dedicating their time and energy to the parks, the programs and the populations served, especially the children of this community, and

WHEREAS, the Park Commission is currently comprised of seven individuals, including a chair, and it has requested that it be expanded by the addition of two alternate members, so as to better serve the community and fulfill its fundamental mission, and

WHEREAS, the Village Board wishes to take this opportunity to thank all members, past and present, and to honor their request for these additional human resources,

**NOW THEREFORE, BE IT ORDAINED** by the Village of Antioch, Lake County, Illinois, as follows:

**SECTION ONE:** Section 2-3-2 of the Antioch Municipal Code is hereby amended and shall hereafter read as follows (additions <u>underlined</u>, deletions <u>stricken</u>):

### 2-3-2: MEMBERSHIP:

- A. Appointment: The park commission shall consist of seven (7) members, including a chair. Additionally, there shall be two (2) alternate members. The chair-and-, members and alternates shall be appointed by the mayor on the basis of their particular fitness for their duty on the park commission, and subject to the approval of the village board of trustees.
- B. Residency Requirements: The members shall reside within the corporate limits of the village or within territory contiguous to the village and not more than one and one-half (1-1/2) miles beyond the corporate limits and not included within any other municipality.
- C. Organization: The members of the park commission shall appoint a secretary from their members or may appoint a secretary to assist them, with the secretary's compensation to be established by the village board of trustees as set forth on the schedule maintained by the Administrator. This appointment shall be by a majority vote of the park commission.

- D. Term Of Office: Each member of the commission shall serve for a period of five (5) years, or until their successors are appointed and have qualified; provided that the members of the commission first appointed, shall be appointed for such terms that the term of one member shall expire annually thereafter. If a vacancy occurs in the office of any commission member, the mayor shall appoint a successor, with the approval of the village board of trustees, to serve for the unexpired term. Alternates shall also serve for five (5) year terms, staggered by initially appointing one alternate to a three (3) year term and the other to a full five (5) year term and all appointments being for five (5) year terms thereafter.
- E. Compensation: Members shall receive fifteen dollars (\$15.00) per meeting, except no member shall receive more than fifteen dollars (\$15.00) in any one month compensation at the rate established in the schedule maintained by the Administrator.

**SECTION TWO:** Section 2-3-3 of the Antioch Municipal Code is hereby amended and it shall hereafter read as follows:

### 2-3-3: PROCEDURES:

- A. <u>ORGANIZATION</u>. Immediately following their appointment, the members of the park commission shall meet, organize, elect a secretary and adopt, and later change or alter, rules and regulations of organization and procedures consistent with village ordinances and state laws.
- B. RECORDS AND REPORTING. The commission shall keep written records of these proceedings, which shall be open at all times to public inspection. The commission shall also file an annual report with the mayor and village board of trustees, setting forth its transactions and recommendations.
- C. ALTERNATES. Alternate members shall have the right to attend all meetings and functions of the Park Commission. They may speak in turn at all meetings in the same manner as a regular board member. In the event one of the regular members should not attend a scheduled meeting, the first alternate appearing for the meeting shall be entitled to vote and participate in the same fashion, and to the same effect as a regular board member. If a second regular member should not appear, then his or her seat shall be filled by the second alternate to appear at the meeting, with similar powers and effect.
- D. LATE ARRIVALS. In the event a member shall not be able to attend a meeting, he or she is required to inform the Parks Director as soon as possible. If the meeting must start in his or her absence following such notice, an alternate member shall take his or her place, and once the regular member arrives, the alternate shall sit through the then-pending discussion, vote on that topic, then cede the seat to the regular member.

## If the regular member fails to notify the Parks Director, then he or she shall not be entitled to participate in the meeting and shall not receive compensation therefore.

**SECTION THREE:** This Ordinance shall be in full force and effect from and after its passage, approval and publication as required by law.
