#### **ORDINANCE 14-10-25**

# AN ORDINANCE ADDING ONE MORE CLASS D LIQUOR LICENSE FOR GRAHAM ENTERPRISE, INC.

WHEREAS, the Village Board has been petitioned by the corporate owner of Graham Enterprise, Inc. who owns the property located at 359 W. North Avenue, and in particular, asked that they be granted an additional Class D liquor license which will allow them to conduct retail sales of beer and wine, and

WHEREAS, on or about October 6, 2014, the former liquor license holder, GHM Enterprises d/b/a 7-11, relinquished their liquor license at that location and went out of business, and

WHEREAS, the Village Board has considered the petition and has determined that the proposal is appropriate for the suggested location and type of business, and that the petitioner is an appropriate designated licensee, having been operated many other retail packaged goods liquor outlets with an exemplary record of compliance with the liquor laws for many years, and

WHEREAS, the Village Board wishes to expand business opportunities wherever possible, for the overall benefit of the citizens and taxpayers of this Village,

**NOW THEREFORE, BE IT ORDAINED** by the Village of Antioch, Lake County, Illinois, as follows:

**SECTION ONE:** The Village Clerk, acting as the Secretary of the Local Liquor Commissioner is directed to revise the chart of allowed liquor licenses to increase the number of Class D license by 1effective at such time as Graham Enterprise, Inc. has secured a certificate of occupancy and qualified for a Village of Antioch Liquor License.

**SECTION TWO:** This Ordinance shall be in full force and effect from and after its passage, approval and publication as required by law.
