ORDINANCE 15-01-02

AN ORDINANCE RATIFYING THE ACTS OF THE CLERK IN CORRECTING A SCRIVENER'S ERROR AND FILING A REFERENDUM ORDINANCE AND FURTHER RATIFYING THE CORRECTED ORDINANCE ITSELF

WHEREAS, on December 1, 2014, the Village Board adopted Ordinance No. 14-12-27, placing a referendum question on the April 7, 2015 consolidated municipal election ballot involving a proposed ambulance tax, and

WHEREAS, the Village Board's intent at all times was to adopt an ordinance which conformed in all aspects of the State's election code, the property tax code and the municipal code, and

WHEREAS, the ordinance so adopted inadvertently contained a scrivener's error in that it referenced the year 2013 in the supplemental language required to be incorporated into the question by the Property Tax Extension Limitation Law, and

WHEREAS, the Clerk corrected this scrivener's error prior to filing the same with the County Clerk, and

WHEREAS, attached hereto and incorporated herein as Exhibit A is a true copy of the said Ordinance No. 14-12-27 as revised by the Clerk aforesaid, and

WHEREAS, the Village Board finds and declares that the original referendum ordinance should have recited the year 2015 in the supplemental language referenced in Section three thereof, and the acts of the Clerk in correcting that date and filing the otherwise unaltered ordinance are in keeping with the intent of the Village Board in adopting the said ordinance, and in forwarding the same to the County Clerk for inclusion on the April 7, 2015 ballot, and

NOW THEREFORE, BE IT ORDAINED by the Village of Antioch, Lake County, Illinois, as follows:

SECTION ONE: The acts of the Clerk in correcting the scrivener's error, changing the date from 2013 to 2015 in the supplemental language set forth in section three of Ordinance No. 14-12-27 are hereby ratified in all respects.


SECTION TWO: The revised Ordinance No. 14-12-27, attached hereto as Exhibit A is ratified in all respects.

SECTION THREE: The Clerk is further directed to contact the County Clerk and take any and all necessary steps to ensure that the said revised ordinance is correctly filed according to law and that the referendum question contained therein is properly placed upon the April 7, 2015 ballot.

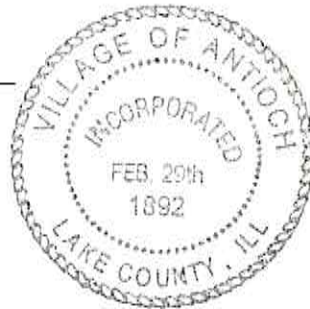
SECTION FOUR: This Ordinance shall be in full force and effect from and after its passage, approval and publication as required by law.

**AN ORDINANCE INITIATING THE SUBMISSION OF A PUBLIC QUESTION TO AUTHORIZE THE
VILLAGE TO IMPOSE A SPECIAL PROPERTY TAX TO PROVIDE AMBULANCE SERVICE**

Whereas, the Village Board finds that it is in the Village citizen's best interests that the Village provide emergency ambulance service to or from points within or without the Village; and

Whereas, the Village Board finds that it will require additional revenue from a dedicated, consistent source to provide such ambulance service; and

Whereas, pursuant to 65 ILCS 5/11-5-7 the Village Board may seek voter approval to raise sufficient revenue to provide ambulance service; and

Whereas, pursuant to the requirements of Illinois Law, the Village of Antioch seeks to place on the April 7, 2015 ballot a public question to be considered by voters in the said Village regarding the authorization of such property tax; and

Whereas, the Village Board wishes to comply fully with all applicable provisions of the Illinois statutes, including the PTELL law previously cited, and

**NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND BOARD OF TRUSTEES OF THE
VILLAGE OF ANTIOCH, LAKE COUNTY, ILLINOIS,** as follows:

SECTION ONE. **RECITALS.** The foregoing recitals are incorporated as if fully set forth in this ordinance.

SECTION TWO. **PUBLIC QUESTION ON PROPERTY TAX TO PROVIDE AMBULANCE SERVICE.** A public question shall be submitted to the voters of the Village of Antioch, County of Lake, State of Illinois, at the April 7, 2015 election (or at the next available election permitted by general election law), as follows:

Shall the Village of Antioch, Lake County, Illinois, be authorized to levy a new tax for the purposes of providing ambulance services, having the additional tax of .25% of the equalized assessed value of the taxable property therein extended on all taxable property within the Village for such purposes?	<u>YES</u>	<u>NO</u>

SECTION THREE. **SUPPLEMENTAL BALLOT LANGUAGE.** Since section 18-190 of PTELL further requires that a taxing body submitting a new tax levy to the electorate supply the election authority with additional information to be printed on the ballot, the following language is proffered to the County Clerk for inclusion on the ballot along with the public question described above:

- (1) *The approximate amount of taxes extendable at the most recently extended limiting rate is \$3,407,968, and the approximate amount of the taxes extendable if the proposition is approved is \$4,199,047.55.*
- (2) *For the 2015 levy year the approximate amount of the additional tax extendable against property containing a single family residence and having a fair market value at the time of referendum of \$100,000 is estimated to be \$ 83.34.*

SECTION FOUR. **FILING.** The Village Clerk is hereby authorized and directed to file the authorizing Ordinance and other related matters with the appropriate election officials in accordance with applicable law.

SECTION FIVE. **EFFECTIVE DATE.** This ordinance shall become effective following its passage, approval and publication in the manner provided by law.


