ORDINANCE 15-10-13

AN ORDINANCE AMENDING §7-3-10 OF THE MUNICIPAL CODE OF ANTIOCH ADDING TWO STOP SIGNS ON HILLSIDE AND HARDEN

WHEREAS, the Village Board has recently held public meetings on the topic of safety on Hillside Avenue and Harden Street, which are frequently used as a shortcut around the intersection of Illinois Highways 173 and 59, and

WHEREAS, the Village Board has found that additional traffic calming techniques need to be added to these streets in order to improve public safety, and

WHEREAS, among those techniques that are needed are two stop signs at the intersection of the two roads,

NOW THEREFORE, BE IT ORDAINED by the Village of Antioch, Lake County, Illinois, as follows:

SECTION ONE: The chart of stop signs included in Section 7-3-10 of the Antioch Municipal Code is hereby amended, additions underlined, deletions stricken:

Street	Stop At	Direction
Harden	Hillside	east west
Hillside	<u>Harden</u>	North and South

SECTION TWO: This Ordinance shall be in full force and effect from and after its passage, approval and publication as required by law.
