ORDINANCE 16-04-12

AN ORDINANCE ADDING ONE MORE CLASS "B" RESTAURANT LIMITED SERVICE LIQUOR LICENSE FOR THE PIZZA JOIN BIZ, LLC

WHEREAS, the Village Board has been petitioned by the owner of The Pizza Joint who has announced an intention to relocate their existing business from Antioch Township into the Village of Antioch, and who have asked that they be granted an additional Class B liquor license which will allow them limited beer and wine alcohol sales, and

WHEREAS, the Village Board has considered the application and has determined that the proposal is appropriate for the suggested location and type of business, and

WHEREAS, the Village Board wishes to expand business opportunities wherever possible, for the overall benefit of the citizens and taxpayers of this Village,

NOW THEREFORE, BE IT ORDAINED by the Village of Antioch, Lake County, Illinois, as follows:

SECTION ONE: The Village Clerk, acting as the Secretary of the Local Liquor Commissioner is directed to revise the chart of allowed liquor licenses to increase the number of Class B licenses by 1 effective at such time as The Pizza Join Biz, LLC. d/b/a The Pizza Joint and More has secured a certificate of occupancy for the restaurant and qualified for a Village of Antioch Liquor License.

SECTION TWO: This Ordinance shall be in full force and effect from and after its passage, approval and publication as required by law.
