#### **ORDINANCE NO. 17-01-01**

## AN ORDINANCE AMENDING SECTION 4-2B-10 OF THE MUNICIPAL CODE OF ANTIOCH ADDING CLASS K ANCILLARY FOOD SERVICE LICENSE REGULATIONS

WHEREAS, the Village Board has been petitioned by the owners of the Piggly Wiggly grocery store seeking the opportunity to establish a food service area along with a license to serve wine and beer on premises, and

**WHEREAS**, the Village Board has considered the petition and has determined that the proposal is appropriate for the suggested location and type of business, and that the petitioner is an appropriate designated package sales licensee, having been in operation with a long record of compliance with the liquor laws, and

WHEREAS, the Village Board wishes to expand business opportunities wherever possible, for the overall benefit of the citizens and taxpayers of this Village, and

WHEREAS, this particular proposal appears to be a highly attractive amenity being added to the assets of the Village, which should assist the Village Board in improving the overall marketability of the Village and in attracting additional tourists and hotel guests,

**NOW THEREFORE, BE IT ORDAINED** by the Village of Antioch, Lake County, Illinois, as follows:

**SECTION ONE:** Section 4-2B-10 of the Antioch Municipal Code is hereby amended by the addition of the following paragraph K, which shall hereafter read as follows:

- K. Class K: Ancillary food service license. This license authorizes the sale of beer and wine for consumption on premises only. Sales shall be strictly in compliance with the following regulations:
  - 1. Licensees shall be full service grocery stores with a minimum of 20,000 square feet of sales floor;
  - 2. Sales shall be conducted only at a cordoned area of the store and that area shall not exceed 1,000 square feet in size, calculated only the service area, tables, booths and bar and not food preparation or kitchen areas;
  - 3. Patrons shall not be permitted to move out of the cordoned area within the store while carrying any beer or wine;
  - 4. The sales of beer and wine shall only be permitted at such times as the store offers food service within the cordoned area;
  - 5. If the licensee also holds a Class C license which allows sampling, it may offer the sampling within the cordoned area.

**SECTION TWO:** Section 4-2B-11 of the Antioch Municipal Code is hereby amended by the addition to the following paragraph 2, which shall hereafter read as follows:
