#### **ORDINANCE 17-03-07**

## AN ORDINANCE FORMALLY ADOPTING THE ZONING MAP EFFECTIVE MARCH 2017 FOR THE VILLAGE OF ANTIOCH

WHEREAS, the Corporate Authorities of this Village have annually adopted and published an official zoning map for the Village, in accordance with 65 ILCS 5/11-13-19; and

WHEREAS, the ordinances approving zoning map amendments, annexations, and final plats of subdivision during calendar year 2016 and the months of January and February 2017, have been reviewed by the Village Staff, and provided the basis for updating the zoning map; and

WHEREAS, the proposed zoning map has been reviewed by the Department of Planning Zoning and Building, which has recommended its formal adoption at its March 6th, 2017 meeting; and

**NOW THEREFORE, BE IT ORDAINED** by the Village of Antioch, Lake County, Illinois, as follows:

**SECTION I:** The zoning map prepared by the Ross Kaminsky of the Village's Engineering Department and bearing the date of March 1, 2017, be and hereby is adopted as the official zoning map of the Village of Antioch, Illinois, and shall stand as the final expression of the corporate authorities of this Village as to the zoning of the various lots, blocks and parcels of land shown thereon as of February 28<sup>th</sup>, 2017.

**SECTION II:** This Ordinance shall be in full force and effect from and after its passage, approval and publication as required by law.
