ORDINANCE 17-06-15

AN ORDINANCE ADDING ONE CLASS "C" LIQUOR LICENSE, J&S PETRO INC

WHEREAS, the Village Board has been petitioned by the owners of the Antioch BP seeking the opportunity to expand their sales of off premise packaged beer and wine to include alcoholic liquors for their property located at 602 W Route 173, and

WHEREAS, a true copy of the petitioner's proposal is attached hereto as Exhibit A, and

WHEREAS, the Village Board has considered the petition and has determined that the proposal is appropriate for the suggested location and type of business, and that the petitioner is an appropriate designated package sales licensee, having been in operation with a long record of compliance with the liquor laws, and

WHEREAS, the Village Board wishes to expand business opportunities wherever possible, for the overall benefit of the citizens and taxpayers of this Village, particularly where the offerings of the proposed business are unique and aimed at a target market that will likely draw people into town,

NOW THEREFORE, BE IT ORDAINED by the Village of Antioch, Lake County, Illinois, as follows:

SECTION ONE: The Village Clerk, acting as the Secretary of the Local Liquor Commissioner is directed to revise the chart of allowed liquor licenses to increase the number of Class "C" licenses by one, and reduce the number of Class "D" licenses by one.

SECTION TWO: The Class "C" License is \$2,000 annually and the Class "D" License is \$1,300 annually. For this license year, the petitioner shall pay the difference of \$700 for their license fee. All subsequent license fees shall be paid according to Section 4-2B-11 of the Village Code.

SECTION THREE: This Ordinance shall be in full force and effect from and after its passage, approval and publication as required by law.
