**ORDINANCE NO. 18-05-23**

**AN ORDINANCE AUTHORIZING THE VILLAGE ADMINISTRATOR TO SELL,  
SALVAGE OR OTHERWISE DISPOSE OF EQUIPMENT**

**WHEREAS,** the Village of Antioch (“Village”) is a municipality located in Lake County, Illinois, and

**WHEREAS,** the Village Administrator would like to sell, salvage or dispose of vehicles, equipment or materials considered to be surplus property of the Village, and

**WHEREAS,** pursuant to Chapter 65, Act 5 Section 11-76-4 of the Illinois Compiled Statutes, the Mayor and Board of Trustees of the Village of Antioch find the property described in Exhibit “A” now owned by said jurisdiction is no longer useful to said jurisdiction and would be best served by the sale or disposal of the property, and

**WHEREAS,** the equipment to be sold or disposed of are beyond economic repair and every effort will be made to sell such equipment,


**NOW THEREFORE, BE IT ORDAINED** by the Village of Antioch, Lake County, Illinois, as follows:
