ORDINANCE 18-06-26

AN ORDINANCE ADDING ONE CLASS C E-CIGARETTE RETAILER'S LICENSE FOR THE LIFTED VAPE LOUNGE

WHEREAS, the Village Board has been petitioned by Devondale LLC Series A, d/b/a Lifted Vape Lounge, the intended retail operator of a proposed e-cigarette and vape shop which has a lease on a property located at 320 West Route 173, and in particular, the petition seeks the creation and granting of an additional Class C e-cigarette retailer's license which will allow them to conduct retail sales of electronic cigarettes and vaping products, and

WHEREAS, the Village Board has considered the petition and has determined that the proposal is appropriate for the suggested location and type of business, and that the petitioner is an appropriate designated licensee, and

WHEREAS, the Village Board wishes to expand business opportunities wherever possible, for the overall benefit of the citizens and taxpayers of this Village, particularly where the offerings of the proposed business are unique and aimed at a target market that will likely draw people into town,


NOW THEREFORE, BE IT ORDAINED by the Village of Antioch, Lake County, Illinois, as follows:

SECTION ONE: The Village Clerk is directed to revise the chart of allowed tobacco and e-cigarette licenses to increase the number of Class C licenses by 1, effective at such time as the Lifted Vape Lounge has secured a certificate of occupancy, based upon completion of the build-out of the space in substantial conformance with the plans and concepts presented to the Village Building Department, and it has further qualified for a Village of Antioch e-cigarette retailer's License by passing the background check required by Section 4-14-6 of the Antioch Municipal Code.

SECTION TWO: This Ordinance shall be in full force and effect from and after its passage, approval and publication as required by law.


