ORDINANCE 19-02-03

AN ORDINANCE RENAMING ONE STREET AND DEDICATING AN ADDRESS FOR HANDI-FOIL CORP.

WHEREAS, Handi-foil Corp. is in the process of constructing a large factory building on a property located on Brookfield Drive in the IDI Industrial Park, and

WHEREAS, access to the Handi-foil factory building is obtained through Gregory Drive, and

WHEREAS, Handi-foil Corp. is poised to become one of the largest overall employers within the Village and the largest private employer, and

WHEREAS, the corporate authorities recently approved an amendment to the TIF district in the IDI Industrial Park to provide financial assistance to the development of the Handi-foil factory building and surrounding properties, all with the intention of providing a high-tech industrial campus that will continue to attract major investment from industrial users, and

WHEREAS, the existing name of Brookfield Drive was designated by IDI in the original plat, apparently without reference to any persons or families tied historically to Antioch, and IDI has further indicated that it has no objection to renaming Brookfield Drive to Handi-foil Drive.

WHEREAS, the Village Board finds that renaming Brookfield Drive to Handi-foil Drive will more closely tie into the current development scheme and will demonstrate a significant business-friendly approach to dealing with potential developers and future business investors, and

WHEREAS, the Village Board further finds that renumbering the Handi-foil factory building will serve the same purpose of demonstrating that Antioch welcomes the investment in dollars and jobs offered by major employers, particularly national companies, and

WHEREAS, the Village Board further finds that granting an honorary name to Gregory Drive will also closely tie into the current development scheme and will demonstrate a significant business-friendly approach to dealing with potential developers and future business investors, and IDI has further indicated that it has no objection to granting an honorary name to Gregory Drive, and

WHEREAS, the Village Board further finds that no hardship will accrue to any businesses or owners of property by the renaming of Brookfield Drive or the granting of an honorary name to Gregory Drive.

NOW THEREFORE, BE IT ORDAINED by the Village of Antioch, Lake County, Illinois, as follows:

SECTION ONE: Brookfield Drive is hereby renamed and it shall hereafter be known as Handi-foil Drive.

SECTION TWO: The property currently known as 1240 Brookfield Drive is hereby designated as 1 Handi-foil Drive.

SECTION THREE: Gregory Drive is hereby granted the honorary name of Honorary Norton's Way.

SECTION FOUR: The United States Postal Service and all other governmental agencies with any jurisdiction over the naming and numbering of streets within municipalities are requested to acknowledge these changes as soon as practical.

SECTION FIVE: This Ordinance shall be in full force and effect from and after its passage, approval and publication as required by law.
