ORDINANCE 19-03-13

AN ORDINANCE FORMALLY ADOPTING THE ZONING MAP EFFECTIVE MARCH 2019 FOR THE VILLAGE OF ANTIOCH

WHEREAS, the Corporate Authorities of this Village have annually adopted and published an official zoning map for the Village, in accordance with 65 ILCS 5/11-13-19; and

WHEREAS, the ordinances approving zoning map amendments, annexations, and final plats of subdivision during calendar year 2018, have been reviewed by the Village Staff, and provided the basis for updating the zoning map; and

WHEREAS, the proposed zoning map for the year ending on December 31, 2018 has been reviewed by the Department of Planning Zoning and Building, which has recommended its formal adoption at its March 11, 2019 meeting; and

NOW THEREFORE, BE IT ORDAINED by the Village of Antioch, Lake County, Illinois, as follows:

SECTION I: The zoning map prepared by the Ross Kaminsky of the Village's Engineering Department and bearing the date of January 1, 2019, be and hereby is adopted as the official zoning map of the Village of Antioch, Illinois, and shall stand as the final expression of the corporate authorities of this Village as to the zoning of the various lots, blocks and parcels of land shown thereon as of January 1, 2019

SECTION II: This Ordinance shall be in full force and effect from and after its passage, approval and publication as required by law.
