ORDINANCE 19-04-15

AN ORDINANCE ADDING ONE CLASS "A" AND ONE CLASS "A-1" LIQUOR LICENSE FOR CORNICIONES LLC LOCATED AT 1200 MAIN STREET

WHEREAS, the Village Board has been petitioned by Alexander Kaliakmanis on behalf of his corporation known as "Corniciones, LLC", and

WHEREAS, the petitioner has advised the Board that Corniciones, LLC intends to open an establishment known as Corniciones, at the former site of 1200 Embers which operated under a Class "A" and "A-1" liquor license until its closure in 2017, and

WHEREAS, the applicant has completed a background check and investigation through the Antioch Police Department, who subsequently provided a report of their findings to the liquor commissioner, and

WHEREAS, the Village Board has considered the application and has determined that the proposal is appropriate for the suggested location and type of business, and it is an appropriate designated licensee, and

WHEREAS, the Village Board wishes to expand business opportunities wherever possible, for the overall benefit of the citizens and taxpayers of this Village, and

WHEREAS, the Village Board further finds that prorating the fees for issuance of the license to Corniciones, LLC is appropriate in view of the very limited amount of time remaining for this license year,

NOW THEREFORE, BE IT ORDAINED by the Village of Antioch, Lake County, Illinois, as follows:

SECTION ONE: The Village Clerk, acting as the Secretary of the Local Liquor Commissioner is directed to revise the chart of allowed liquor licenses as necessary to allow an additional Class "A" and Class "A-1" liquor license to Corniciones, LLC once all necessary paperwork has been submitted and the applicants qualify for a license.

SECTION TWO: The fees for issuance of the liquor license to Corniciones, LLC shall be prorated to the amount due of \$500 for the remainder of the current license year expiring May 31, 2019, with the full fee due for the license commencing June 1, 2019.

SECTION THREE: This Ordinance shall be in full force and effect from and after its passage, approval and publication as required by law.
