#### ORDINANCE 19-05-17

# AN ORDINANCE DECLARING THE EMERGENCY MANAGEMENT COMMAND TRAILER SURPLUS AND DONATING IT TO THE ILLINOIS INCIDENT MANAGEMENT TEAM

WHEREAS, Frank Schmidtke previously generously donated a fully outfitted Emergency Command trailer to the Village in memory of his deceased brother John, and

WHEREAS, John Schmidtke was long recognized as a dedicated man who loved the Village of Antioch and was committed to helping ensure public safety through long hours of devoted work with the Antioch Emergency Management Agency, and

WHEREAS, with the passage of time and the expansion of more modern regional emergency management systems and protocols, the functional use of this Emergency Command Trailer has been superseded and it has not been used for a significant period of time, and

**WHEREAS**, the Village Board finds and declares that the Emergency Command Trailer owned by the Village is surplus and should be disposed of in the most responsible manner possible, consistent with the provisions of 65 ILCS 5/11-76-4, and

WHEREAS, the original donor, Frank Schmidtke has suggested to the Village Board that the trailer could be effectively used by the Illinois Incident Management Team where it would be a material aid to their work in managing and controlling large scale incidents throughout the State of Illinois, and a copy of his letter dated April 18, 2019 is attached as Exhibit A hereto, and

WHEREAS, the Illinois Emergency Management Team provides management expertise from approximately 70 member agencies including law enforcement, fire and emergency management agencies and it responds immediately when called upon to assist with major incidents such as tornadoes, floods, wildfires and hazardous materials incidents as well as preparedness training, and

WHEREAS, the Illinois Emergency Management Team has agreed to accept the Emergency Command Trailer in "as-is" condition and to put it to public use as described in their letter dated April 18, 2019, a copy of which is attached as Exhibit B hereto, and

WHEREAS, the Village Board finds that honoring the wishes of Frank Schmidtke and donating the Emergency Command Trailer to the Illinois Incident Management Team is a highly appropriate way of passing on the generous donation in honor of our former citizen, John Schmidtke,

NOW THEREFORE, BE IT ORDAINED by the Village of Antioch, Lake County, Illinois, as follows:

**SECTION ONE:** The Mayor and Clerk are authorized to execute any and all titles, bills of sale or other transactional documents necessary to complete the donation of the Emergency Command Trailer to the Illinois Incident Management Team in "as-is" condition and without warranty of any kind.

**SECTION TWO:** This Ordinance shall be in full force and effect from and after its passage, approval and publication as required by law.
